REPORT OF THE AUDITORS TO DUMISS TRADE LIMITED PURSUANT TO PARAGRAPH 24 OF SCHEDULE 8 TO THE COMPANIES ACT 1985

We have examined the abbreviated financial statements on pages 3 to 6 together with the financial statements of Dumiss Trade Limited prepared under section 226 of the Companies Act 1985 for the year ended 31 March 1996.

Respective responsibilities of directors and auditors

BASIS OF ACCOUNTING

The abbreviated financial statements have been prepared under the historical cost convention.

TURNOVER

Turnover represents the invoiced amounts of goods sold net of Value Added

TANGIBLE FIXED ASSETS

Tangible fixed assets are stated at cost less depreciation.

Depreciation is provided on all tangible fixed assets, at rates calculated to write off the cost or valuation, less estimated residual value, of each asset evenly over its expected useful life, as follows:

Office furniture and equipment - over 5 years
Computer equipment - over 3 years

FOREIGN CURRENCIES

Assets and liabilities denominated in foreign currencies are translated at the rate of exchange ruling at the balance sheet date.

Transactions in foreign currencies are recorded at the rate ruling at the date of the transaction.

All differences are taken to the profit and loss account.

OPERATING LEASES

Annual rentals of land and buildings are charged to the profit and loss account on a straight-line basis over the lease term.
