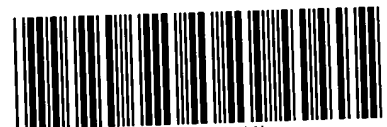

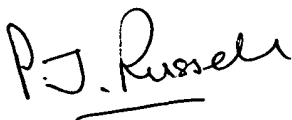

Report of the Directors for the period  
1<sup>st</sup> January 2013 to 31<sup>st</sup> December 2015

- 1 The Company was incorporated on 10<sup>th</sup> December 1991 with the name of Valdaze Limited. Two capital shares of £1 each were issued by the company. The name of the company was changed to Eurolab (UK) Limited on 27<sup>th</sup> January 1992 and the two issued shares were transferred to:
  - 1 British Measurement and Testing Association. Registered address: 10 Grosvenor Gardens, London, SW1W 0DQ.
  - 2 British Measurement and Testing Association, (nominee David Harry Stanger). Summerfield House, Barnet Lane, Elstree, Hertfordshire, WD6 3HQ.
- 2 The registered address of the British Measurement and Testing Association was changed to East Malling Enterprise Centre, New Road, East Malling, Kent ME19 6BJ.
- 3 The share registered to British Measurement and Testing Association (nominee David Harry Stanger) subsequently transferred to British Measurement and Testing Association (nominee Kenneth John Albutt) has been transferred to British Measurement and Testing Association (nominee Peter John Russell).
- 4 The company has been dormant, as defined by the Companies Act 1985, since its formation but its name is used by the British Measurement & Testing Association (BMTA) as the title of the UK member of EUROLAB. All financial activity of EUROLAB (UK) Ltd is conducted through BMTA.
