Statement of Directors' Responsibilities

1 Statement of Accounting Policies

The financial statements have been prepared in accordance with applicable accounting standards issued by UK accountancy bodies. 5 Ultimate controlling party

The whole of the issued share capital is held by Farringtons School, a registered charity. By deed of covenant dated 8 July 1992 the taxable profits are payable to the school. The ultimate controlling party at the balance sheet date was the Methodist Independent Schools Trust. The company has taken advantage of FRS8 exemptions from disclosure of inter-group transactions.

6 Operating Profit

The operating profit is stated after charging an audit fee of £2,250 (2014: £2,150). The profit for the year of £69,300 will be paid to Farringtons School as provided by the Deed of Covenant.

7 Taxation

There is no liability to corporation tax for the year.
