Annual General Meeting for members - attendance of 50 to debate on the future of Friends of Castle Green CIC.

Youth Canoe Facility: Voluntary run canoe sessions for more than 60 youths, aged 11-18 years on the River Wye from May to October. Over 290 volunteer hours given, 80 certificates achieved and 15 training sessions given to 18 year olds to achieve Level 1 canoeing.

In partnership with Music Pool and Close House we have hosted the Livewire music project in the Pavilion for 99 Herefordshire young people aged 13-25yrs. 50% of these young people were in "challenging circumstances".
