# Mathematical Analysis

The first part of the course deals with the theory of functions of a real variable. It begins with the definition of a function and its properties, such as continuity and differentiability. The second part of the course deals with the theory of integration, including the Riemann integral and the Lebesgue integral.

## Integration

The theory of integration is one of the most important parts of mathematical analysis. It deals with the problem of finding the area under a curve, which is known as the integral of the function. The Riemann integral is the most common type of integral, but there are other types, such as the Lebesgue integral, which is more general and powerful.

## Differentiation

The theory of differentiation is another important part of mathematical analysis. It deals with the problem of finding the slope of a curve at a given point, which is known as the derivative of the function. The derivative is a powerful tool for solving problems in physics and engineering.

The theory of differentiation is closely related to the theory of integration. In fact, the derivative of a function is the inverse of the integral of the function. This relationship is known as the Fundamental Theorem of Calculus.

## Series

The theory of series is another important part of mathematical analysis. It deals with the problem of finding the sum of an infinite sequence of numbers. There are many different types of series, but the most common ones are the arithmetic series and the geometric series.
