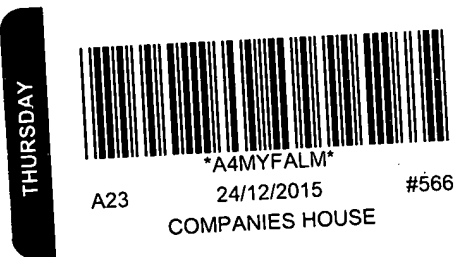


For the year ending 31st March 2015 the company was entitled to exemption from audit under section 477 (2) of the Companies Act 2006.
