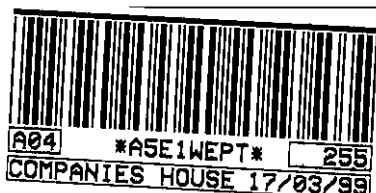

**NOTES**
