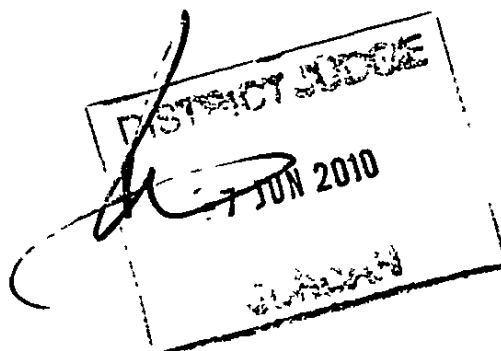
AND UPON READING the Part 8 claim form, the witness statement of Kelly Marie Gibson dated 2 June 2010 and the legal charge herein mentioned
