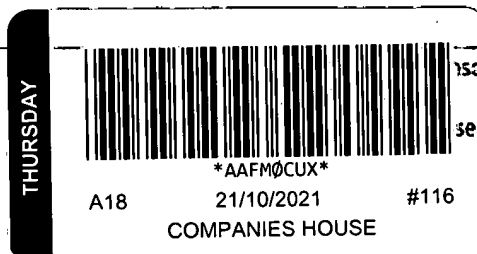

**ORDER**

---

**UPON THE APPLICATION OF THE APPLICANT** dated 6 October 2021

**AND UPON** the Court considering that the order can be made without a hearing

**IT IS ORDERED THAT:**

1. Graham David Randall (**Outgoing Office-holder**) be removed from office in respect of each of the cases listed in Schedules 1-4 attached to this order (**Schedules**) (**Block Transfer Cases**) from the date of this order.
2. Where indicated against each case in the Schedules, Louise Adele Durkan, Richard Thomas Easterby, Elias Paourou, Nicholas Stephen Joseph Parsk or David Patrick Meany (**Replacement Office-holders**) be appointed as joint Replacement Office-holders in respect of the Block Transfer Cases from the date of this order.
3. The removal of the Outgoing Office-holder and appointment of the Replacement Office-holders pursuant to paragraphs 1 and 2 above shall take place without the Outgoing Office-holder being required to (i) apply to the Secretary of State for release or discharge as appropriate pursuant to Section 173(2)(b), Section 174(4)(b) and Section 299 of the Insolvency Act 1986 as the case may be or (ii) file a receipts and payments account.
4. Where the cases referred to in the Schedules are joint appointments, any act required or authorised under any enactment to be done by joint appointees may be done by all or any one or more of the persons at the time being holding office. No functions are required to be undertaken by both joint appointees acting together and no functions are specifically the responsibility of either joint appointee.
5. The creditors, and in the case of members' voluntary liquidations, the members, in each of the Block Transfer Cases listed in the Schedules be notified of this order solely by advertisement published in the London Gazette within 21 days of the date of this order (**Advertisement**).
6. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies listed in the Schedules who has an objection to this order shall have 14 days from the date of the Advertisement (as required at paragraph 5 above) to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the Block Transfer Cases listed in the Schedules until further or other order by the court.

7. The Replacement Office-holders shall give notice to the Secretary of State and, in the case of companies, the Registrar of Companies in respect of the relevant insolvency proceedings listed in the Schedules of the terms of this order as soon as reasonably practicable.
8. The Outgoing Office-holder shall file a copy of this order with each of the courts listed in the Schedules.
9. The Outgoing Office-holder shall receive his release as liquidator and administrator (as specified in the Schedules) 35 days after the notification requirements set out at paragraphs 5 and 7 above have been fulfilled, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 6 of this order for the specific case subject to that application.
10. Pursuant to rules 18.6, 18.7 and 18.8 of the Insolvency Rules 2016, and in respect of the Block Transfer Cases listed in the Schedules, the time by which progress reports are required to be delivered by an office-holder of the Block Transfer Cases shall be unaffected by the change in office-holder.
11. Subject to paragraph 12 below, in the event that, as a result of the implementation of this order Quantuma Advisory Limited (**Quantuma**), incurs any additional cost in respect of the administration of the cases listed in the Schedules over and above those costs incurred in the ordinary course of the administration of those cases, those costs shall be borne by Quantuma and shall not be charged as an expense of the administration of those cases.
12. Nothing contained in paragraphs 11 or 13 shall prejudice the Outgoing Office-holder, the Respondents or the Replacement Office-holders from:
  - a. Charging to each case listed in the Schedules the cost of obtaining an insolvency practitioner's security bond in respect of those cases; and
  - b. Equally apportioning the cost of the Advertisement between the cases listed in the Schedules.
13. The costs of this Application (including VAT) shall be met by Quantuma.

- 14 The Respondents have liberty to apply to the Court to amend this Order to include any appointments held by the Outgoing Office-holder which have been inadvertently omitted from this Application.
