(2) ASSETZ CAPITAL TRUST COMPANY LIMITED (company number 08336441), a company registered in England and Wales whose registered office is at Assetz House, Manchester Green, 335 Styal Road, Manchester, M22 5LW acting in its capacity as security trustee for itself, and the Lending Syndicate Members (the "Security Trustee").

1. DEFINITIONS AND INTERPRETATION

1.1 In this deed:

"Property"

means all, each and any part of the property legally and/or beneficially owned by the Chargor, particulars of which are set out in the Schedule 1 together with (in every case) any buildings, fixtures, fittings, fixed plant or machinery from time to time situated on or forming part of such property, all proceeds of sale deriving from such property, the benefit of all covenants, whether monetary or otherwise given in respect of such property and any monies paid or payable in respect of such covenants;

"Receiver"

"Rent Account"

"Rental Income"

means all rents licence fees and other moneys receivable now or after the date of this deed by the Chargor under or arising out of any lease or licence of the Property or otherwise derived by the Chargor from or in respect of the Property, and including service charges and insurance rents;

"Secured Obligations"

means any Loan and all the indebtedness and all obligations and liabilities owing or incurred by the Chargor to the Finance Parties whether express or implied, present, future or contingent, joint or several, incurred as principal or surety determined in whatever currency or currencies together with Interest (including any at the Default Rate (as the case may be)) and Expenses pursuant to the terms of the Loan Agreement, any other Finance Document and/or this deed or otherwise howsoever when the same become due for payment or discharge;

"Security Assets"

means each, any and all of the assets and undertakings charged pursuant to clause 3 or otherwise the subject of any security created by or pursuant to this deed and includes any part or parts of such assets;

"Security Period"

means the period beginning on the date of this deed and ending on the Discharge Date;

"VAT"

2. COVENANT TO PAY

2.1 The Chargor shall pay or discharge to the Security Trustee all the Secured Obligations when due

3. CHARGING CLAUSE

3.1 Charge

The Chargor, as a continuing security for the payment, discharge and performance of the Secured Obligations:

(a)

- (i) (A) by way of first legal mortgage, grants and demises to the Security Trustee all of the Property to hold so much of the same as is of freehold tenure to the Security Trustee for a term of 10,000 years from the date of this deed and to hold so much of the same as is of leasehold tenure to the Security Trustee for the residue of the respective term or terms of years for which the Chargor now holds same less the last three days of each of such term or terms and (B) by way of first legal charge charges to the Security Trustee all the Property as is registered or is to be registered in the Land Registry of Northern Ireland with payment of the Chargor's liabilities and assents to registration of the charge as a burden on the folio(s) above mentioned;
- (ii) by way of first fixed charge, charges to the Security Trustee:
 - (to the extent that the Property is not for any reason effectively charged by way
 of legal mortgage and/or legal charge under this deed) the Property including
 all the Chargor's other interests in the Property;
 - II. all buildings and structures, plant and machinery and chattels now or at any time located on, but which are not affixed to or do not form part of, the Property and which are not of a nature regularly disposed of in the ordinary course of business;

 - the benefit of all rights and claims of the Chargor now or at any time against managing agents, professional advisors' suppliers, or contractors in relation to the Property;
 - (iii) the benefit of all Permits now or at any time held by the Chargor in connection with any business carried on at the Property;
 - (iv) the benefit of all guarantees insurances, or compensation monies now or at any time relating to any of the Security Assets;
 - (v) the benefit of any agreements or arrangements now or at any time entered into with any person for the purpose of or in connection with the fixing capping or hedging of the rate of interest payable by the Chargor in respect of any borrowing from or indebtedness to the Security Trustee and any right or option to enter into any such agreement or arrangement;
 - (vi) all monies now or at any time standing to the credit of the Rent Account;
 - (vii) any share or membership rights in a residents' association or management company relating to the Property;
 - (viii) any other benefits or rights of any kind now or at any time relating to the Property, its use, construction or title;
- 3.2 The Chargor shall procure that all Rental Income (if any) is paid directly to the Rent Account and, immediately on demand by the Security Trustee at any time, shall give written notice to its tenants and other occupiers of the Property to pay all Rental Income directly to the Rent Account. Upon such demand, the Chargor shall hold any Rental Income received by it upon trust for the Security Trustee until payment to the Security Trustee.
- 3.3 The Chargor shall stand possessed of the reversion immediately expectant upon the term of years hereby granted in any part of the Property mortgaged by Clause 3.1(a)(i)(A) of this Deed in trust for the Security Trustee and agrees to assign, convey or dispose of the same as the Security Trustee may direct (subject to the proviso for redemption contained herein) and the Security Trustee may at any time during the continuance of the security hereby created remove the Chargor or any other person, persons or body corporate from being a trustee of the trust declared by this Clause 3.3 and on the removal of the Chargor or such other person, persons or body corporate appoint a new trustee or trustees in his, their or its place.

3.4 The Chargor hereby attorns tenant to the Security Trustee of any part of the Properties mortgaged by Clause 3.1(a)(i)(A) at the yearly rent of five pence (if demanded) provided always that the Security Trustee may at any time without notice to the Chargor determine the tenancy hereby created and enter upon such part of the Security Assets but so that neither the receipt of the said rent nor the said tenancy shall render the Security Trustee liable to account to any person as mortgagee in possession. All the security created or given under this deed is made as Beneficial Owner in accordance with Section 7 of the 1881 Act.

4. LAND REGISTRATION

4.1 Land Registry

- The Chargor within the applicable time limits is to apply to the Registrar of Titles for (a) registration of the following inhibition in the above mentioned folio(s) (and against any title to any unregistered property comprised in the Property which is or ought to be the subject of a first registration of title at the Land Registry of Northern Ireland at the date of this Deed)::
 - "Except under an order of the Registrar, no disposition or dealing is to be registered without the consent of the Registered Owner for the time being of the Charge or Mortgage dated []."
- (b) The Security Trustee, in its absolute discretion, may make the application referred to in clause 4.1(a) in place of the Chargor. The Chargor consents to the entry of such inhibition and will pay the Expenses on demand incurred in connection with such application.

4.2 **Further Assurance**

The Chargor is (whether directly or indirectly) at its own expense to do whatever the Security Trustee may reasonably require in perfecting, validating, registering and/or filing of the security constituted by this deed or any other matter in connection with the security constituted by this deed.

5. **NEGATIVE PLEDGE**

5.1 The Chargor shall not:

- 6.1 The Chargor represents and warrants to the Security Trustee on the date of this deed and on each day on which the Secured Obligations are outstanding that:
 - (a) the execution of this deed by the Chargor and the content of this deed will not:
 - (i) conflict with or result in any breach of any law or regulation;
 - (ii) constitute a default, acceleration of payment or termination event (however described) under any agreement or instrument binding upon it; and
 - (b) it has all necessary Authorisations required or desirable for the execution, delivery, issue, validity or enforceability of this deed or of the performance of the Chargor's obligations or the exercise of its rights under this deed.

7. PROPERTY WARRANTIES

- 7.1 The Chargor further represents and warrants to the Security Trustee on the date of this deed and on each day on which the Secured Obligations are outstanding that:
 - (a) it is the legal and beneficial owner of the Property;
 - (b) all Authorisations required or desirable for the continued use of the Property for its present purpose have been obtained and have not been (and the Chargor is not aware of any circumstance having arisen whereby they might be) withdrawn;
 - (c) it has not received notice of any adverse claim by any person in respect of the ownership of the Property or any interest in the Property.
 - (d) there is no breach of any law or regulation which materially and adversely affects the value of the Security Assets;
 - (e) there are no covenants, agreements, reservations, conditions, interests, rights or other matters or any nature which materially and adversely affects the Security Assets;
 - (f) no facility necessary for the use and enjoyment of the Property is subject to terms entitling any person to terminate or curtail its use;
 - (g) it has obtained all requisite environmental licences applicable to it and has at all times complied in all material respects with the terms of those environmental licences and all other applicable environmental law;
 - (h) save as disclosed to the Security Trustee prior to the date of this deed, no dangerous hazardous, toxic waste or substance or substance capable of damaging the environment has been used disposed of, generated, stored, transported, dumped, deposited, buried or emitted at, on, from or under the Property in circumstances where this results in a liability on the Chargor;
 - nothing has arisen or has been created or is subsisting which is or would be an overriding interest or an unregistered interest which overrides first registration or a registered disposition over the Property;
 - (j) for the purposes of the Council of the European Union Regulation no. 1356/2000 on Insolvency Proceedings (the "Regulation"), the Chargor's centre of main interests (as that term is used in Article 3(1) of the Regulation) is situated in the United Kingdom.

8. UNDERTAKINGS

8.1 Undertakings

The Chargor undertakes to the Security Trustee throughout the Security Period that:

- it will comply in all respects with the insurance undertakings set out in the Loan Agreement and will ensure that the interest of the Security Trustee is noted on the relevant policy or policies;
- (b) it will upon the Security Trustee's written request take all steps and execute all documents necessary:
 - to render effective and valid any security or any right or power created or intended to be created or evidenced under or by this deed but which is or may be ineffective or invalid;

- (c) it will pay all Expenses on demand and if it does not do so, the Expenses will bear interest at the Default Rate from and including the date of demand to and including the date of payment;
- (d) it shall comply in all respects with the provisions of all statutes and subordinate legislation (including, but not limited to, those relating to planning and environmental matters) which apply to the Property or any other Security Asset or to any business for the time being carried on at the Property;
- (e) it shall if requested by the Security Trustee promptly give notice to any person who is a party to a document or proceeding involving the Chargor the benefit of which is assigned or charged to the Security Trustee under this deed of the Security Trustee's interest in the relevant Security Asset and shall use its reasonable endeavours to procure that such person acknowledges receipt of such notice;
- (f) where the Property at any time is or includes premises in respect of which a Permit is in force, whether under the Licensing (Northern Ireland) Order 1996 or any other legislation, it shall take all necessary steps to ensure the renewal or continuation of any Permit and not do or allow to happen anything which might adversely affect any such Permit:
- (g) the Security Trustee may (following an Event of Default or Potential Event of Default) enter the Property with its advisers, contractors, equipment and materials at reasonable times during the day to inspect and survey the Property and any plant and machinery on the Property and carry out any environmental survey in respect of the Property The Security Trustee shall not by doing so become a mortgagee in possession. The Security Trustee may recover from the
- (h) Chargor on demand all reasonable expenses incurred and money spent in doing so, which shall form part of the Secured Obligations and shall carry interest at the rate specified in the Loan Agreement;
- (i) it shall not enter into any sale agreement or other agreement or deed in respect of the Property without the prior written approval of the Security Trustee (acting reasonably):
- (j) it shall properly discharge all duties or care and responsibilities placed upon the Chargor by Environmental Law and observe and perform all the requirements of Environmental Law both in the conduct of its general business and in the management possession or occupation of the Property and shall apply for and obtain all authorisations, licences and consents necessary to ensure that it does not breach Environmental Law:

8.2 Cure Rights

If the Chargor fails to comply with any of the covenants and undertakings set out under this deed it will allow and hereby irrevocably authorises the Security Trustee and any nominee of the Security Trustee to take such action (including the making of payments) on behalf of the Chargor that is necessary to ensure that such covenants and/or undertakings are complied with and if such payment is made by the Security Trustee or its nominee on behalf of the Chargor such payment amount shall be added to and form part of the Secured Obligations.

8.3 Further Advances under Existing Security

The Chargor shall neither request nor accept any further advance under any prior legal charge in respect of the Property.

9. ENFORCEABILITY

This deed will become enforceable and the power of sale shall be exercisable upon the occurrence of an Event of Default.

10. ENFORCEMENT OF SECURITY

10.1 Power to appoint Receiver

At any time after the Security Trustee's power of sale has become exercisable, the Security Trustee may appoint one or more than one Receiver in respect of the Security Assets or any of them and if more than one Receiver is appointed the Receiver may act jointly and severally or individually.

10.2 Power to remove a Receiver

The Security Trustee may remove the Receiver and appoint another Receiver and may also appoint an alternative or additional Receiver.

10.3 Receiver as agent

The Receiver will, so far as the law permits, be the agent of the Chargor. The Chargor will be solely responsible for the acts or defaults of the Receiver and will be liable on any contracts or obligations made or entered into by the Receiver. No Finance Party will be responsible for any misconduct, negligence or default of the Receiver.

10.4 Receiver's powers continue

The powers of the Receiver will continue in full force and effect following the liquidation or bankruptcy of the Chargor (as the case may be).

10.5 Remuneration of Receiver

The remuneration of the Receiver will be payable by the Chargor and will form part of the Secured Obligations.

10.6 Receiver's powers

The Receiver will have the power on behalf of the Chargor:

- to do or omit to do anything which he considers appropriate in relation to the Security Assets in such manner as he thinks fit;
- (b) to exercise all or any of the powers conferred on the Receiver or the Security Trustee under this deed or conferred upon administrative receivers by the Insolvency Act (even if he is not an administrative receiver), or upon receivers by the Conveyancing Acts or any other statutory provision (even if he is not appointed under the Conveyancing Acts or such other statutory provision);
- (c) to enter upon, take possession of and generally operate and manage the Security Assets;
- (d) to commence and/or complete any building operations or development on the Property and apply for and obtain any planning permissions, building regulation approvals and any other permissions, consents or licences and may appoint and enter into contracts with building and engineering contractors or other contractors or professional advisors in each such case as he may think fit;

- (i) to settle, adjust, refer to arbitration or expert determination, compromise and arrange any claims, accounts, disputes, questions and demands with or by any person or body who is or claims to be a creditor of the Chargor or relating in any way to the Security Assets:
- to give valid receipts for all moneys and execute all assurances and things which may be proper or desirable for realising the Security Assets;
- (k) to insure the Security Assets, any assets acquired by the Receiver in exercise of his powers, and any business or works, and effect indemnity insurance or other similar insurance, in every case in such amounts, against such risks and with such offices as the Receiver thinks fit, and obtain bonds and give indemnities and security to any bondsmen;
- (I) to redeem any prior security (or procure the transfer of such security to himself) and settle and pass the accounts of the person entitled to the prior security so that any accounts so settled and passed shall (subject to any manifest error) be conclusive and binding on the Chargor and the money so paid shall be deemed to be an expense properly incurred by the Receiver; and
- (m) either in the name of the Chargor or in the name of the Receiver to execute documents and do all other acts or things which the Receiver may consider to be incidental or conducive to any of the Receiver's powers or to the realisation or use of the Security Assets.

10.7 Security Trustee may exercise powers

The Security Trustee may, at any time after this deed has become enforceable pursuant to clause 9, exercise, to the fullest extent permitted by law, all or any of the powers authorities and discretions conferred on a Receiver by this deed, whether as attorney of the Chargor or otherwise and whether or not a Receiver has been appointed.

10.8 Ability to vary powers

The Security Trustee may, in writing, either in its appointment of a Receiver or by subsequent notice to that Receiver, restrict the right of such Receiver to exercise all or any of the powers conferred on Receivers by this deed or by law.

11. APPLICATION OF PROCEEDS

11.1 Order of application

The proceeds arising from the exercise of the powers of the Receiver will, subject to any claims ranking in priority to the Secured Obligations, be applied by or at the direction of the Receiver in or towards discharging or satisfying, in the following order of priority:

- (a) firstly, the costs, charges and expenses of and incidental to the Receiver's appointment and the payment of his remuneration;
- (b) secondly, any costs, charges, expenses and liabilities of or incurred by any Enforcement Party in the exercise of any of its powers;
- (c) thirdly, the Secured Obligations, in such order as the Security Trustee may determine;
- (d) fourthly, the claims of any other persons entitled to any surplus.

11.2 Appropriation of proceeds

The Security Trustee is entitled to appropriate money and/or assets to Secured Obligations in such manner or order as it thinks fit and any such appropriation shall override any appropriation by the Chargor.

11.3 Suspense Account

The Security Trustee may place (for such time as it thinks prudent with regard to applicable laws) any money received by it pursuant to this deed to the credit of a suspense account (without liability to account for interest thereon) for so long and in such manner as the Security Trustee may from time to time determine without having any obligation to apply that money or any part of it in or towards discharge of the Secured Obligations.

11.4 Ruling off accounts

If the Security Trustee receives notice of a subsequent mortgage or charge relating to the Security Assets, it will be entitled to close any account and to open a new account in respect of the closed account. If the Security Trustee does not open such new account, it will in any event be treated as if it had done so at the time when it received such notice.

11.5 Settlements conditional

Any release, discharge or settlement between the Chargor and the Security Trustee shall be conditional upon no security, disposition or payment to the Security Trustee by the Chargor or any other person being void, set aside or ordered to be refunded pursuant to any enactment or law relating to liquidation, administration or insolvency or for any other reason whatsoever and if such condition is not fulfilled the Security Trustee shall be entitled to enforce this deed as if such release, discharge or settlement had not occurred and any such payment had not been made.

12. PROTECTION OF THIRD PARTIES

12.1 Third party dealings

A buyer from, tenant or other person dealing with any Enforcement Party will not be concerned to enquire whether any of the powers which such Enforcement Party has exercised or purported to exercise have arisen or become exercisable and may assume that such Enforcement Party is acting in accordance with this deed.

12.2 Receipt of proceeds

Receipt by the Security Trustee or any Receiver shall be an absolute and a conclusive discharge to a purchaser of the Security Assets and shall relieve such purchaser of any obligation to see

to the application of any monies paid to or by the direction of the Security Trustee or any Receiver.

13. PROTECTION OF SECURITY TRUSTEE/ ENFORCEMENT PARTY

13.1 No liability for Enforcement Party

No Enforcement Party will be liable to the Chargor for any expense, loss, liability or damage incurred by the Chargor arising out of the exercise of its rights or powers or any attempt or failure to exercise those rights or powers except any expense, loss, liability or damage arising from its gross negligence, fraud or wilful misconduct.

13.2 Not mortgagee in possession

If the Security Trustee or any Receiver enters into possession of the Security Assets, or any of them, this will not oblige either the Security Trustee or the Receiver to account as mortgagee in possession, and if at any time the Security Trustee enters into possession of the Security Assets, or any of them, it may at any time at its discretion go out of such possession.

13.3 Indemnity

The Chargor hereby indemnifies each Finance Party and any Receiver or Delegate on demand against any costs, loss or liability incurred by any of them in respect of any exercise of the powers of the Security Trustee and any Receiver or Delegate or any attempt or failure to exercise those powers and anything done or omitted to be done in the exercise or purported exercise of the powers under this deed or under any appointment duly made under the provisions of this deed.

13.4 Preservation of rights

Neither the liability of the Chargor nor the validity or enforceability of this deed shall be prejudiced, affected or discharged by:

- (a) the granting of any time or indulgence to any Obligor or any other person:
- (b) any variation or modification of any facility letter or facility agreement relating to the Secured Obligations or any other documents referred to therein or related thereto or establishing financial indebtedness that forms part of or relates to the Secured Obligations;
- the invalidity or enforceability of any obligation or liability of any party due to the Security Trustee;
- (d) any invalidity or irregularity in the execution of any facility letter or facility agreement or any other agreement establishing indebtedness that forms part of or relates to the Secured Obligations or any other documents referred to therein or related thereto;
- (e) any lack of capacity or deficiency in the powers of any Obligor or any other person to enter into or perform any of its obligations due to a Finance Party or any irregularity in the exercise thereof or any lack of authority by any person purporting to act on behalf of any Obligor or such other person;
- (f) the insolvency, bankruptcy or incapacity, disability or limitation or any change in the constitution or status of any Obligor or any other person;
- (g) any other security interest, encumbrance, guarantee or other security or surety or right or remedy being or becoming held by or available to a Finance Party or by any other person or by any of the same being or becoming wholly or partly void, voidable, unenforceable or impaired or by a Finance Party at any time releasing, refraining from

- any act, omission, event or circumstance which would or may but for this provision (i) operate to prejudice, affect or discharge this deed or the liability of the Chargor under this deed.

POWER OF ATTORNEY 14.

- The Chargor irrevocably and by way of security appoints the Security Trustee and each 141 Receiver and any person nominated for the purpose by the Security Trustee or the Receiver to be the attorney of the Chargor (with full power of substitution and delegation) for any purpose set out in this deed.
- The power of attorney granted in this clause allows the Security Trustee, the Receiver or such 14.2 nominee in the name of the Chargor and on its behalf and as its act and deed to:
 - perfect the security given by the Chargor under this deed; and (a)
 - execute, seal and deliver (using the Chargor's seal where appropriate) any document (b) or do any act or thing which the Chargor has agreed to execute or do under this deed.

15. STATUTORY PROVISIONS

- 15.1 The covenants set out in section 7 of the 1881 Act shall extend to bind the Chargor only if, in any case, the relevant covenant imposes upon the Chargor a burden, liability or obligation that would not otherwise arise under this deed.

- The power of sale and the other powers conferred by the Conveyancing Acts or otherwise are 15.4 extended and varied to authorise the Security Trustee in its absolute discretion to do all or any of the things or exercise all or any of the powers which a Receiver is empowered to do or exercise under this deed.
- The restriction on the consolidation of mortgages in Section 17 of the 1881 Act does not apply 15.5 to this deed nor to any security given to the Security Trustee pursuant to this deed.
- 15.6 The restrictions on the powers of the Security Trustee or the Receiver to grant leases or to accept the surrender of leases in section 18 of the 1881 Act and section 3 of the 1911 Act do not apply to this deed.

17.1 Continuing security

This deed shall remain in full force and effect as a continuing security for the Secured Obligations, despite any settlement of account, or intermediate payment, or other matter or thing, unless and until the Security Trustee discharges this deed in writing.

17.2 Waivers

Time shall be of the essence under this deed but no failure or delay on the part of the Security Trustee to exercise any power, right or remedy under this deed shall operate as a waiver thereof, nor shall any single or partial exercise by the Security Trustee of any power, right or remedy preclude any other or further exercise thereof or the exercise of any other power, right or remedy.

17.3 Remedies

The remedies provided in this deed are cumulative and are not exclusive of any remedies provided by law.

17.4 Amendment

Any amendment or waiver of any provision of this deed and any waiver of any default under this deed shall only be effective if made in writing and signed by the Security Trustee for and on behalf of itself and the Finance Parties.

17.5 Statement of Account

Any statement of account signed as correct by the Security Trustee showing any amount due under this deed shall, in the absence of manifest error, be conclusive evidence of the amount so due.

17.6 Severability

If any provision of this deed is prohibited or unenforceable in any jurisdiction such prohibition or unenforceability shall not invalidate the remaining provisions hereof or affect the validity or enforceability of such provision in any other jurisdiction.

17.7 Assignment

The Security Trustee may assign and/or transfer any or all of its rights under this deed. The Chargor shall not assign or transfer any of its rights or obligations under this deed.

17.8 Successors and Assigns

This deed shall bind and shall inure for the benefit of each of the parties hereto and each of their respective successors and permitted assigns.
