Before District Judge Richmond on 22 March 2021

UPON THE APPLICATION dated 18th January 2021

AND UPON READING the papers recorded on the court file as having been
read

AND UPON NOTING that notice had been given to the Secretary of State in advance of the application pursuant to Rule 12.37(6) of the Insolvency (England and Wales) Rules 2016

IT IS ORDERED THAT:

For an order that:

1. The Applicant has leave to make a composite application in respect of the insolvency proceedings identified in the Schedules A to F to this Application (the “**Schedules**”);
2. The proceedings listed in the Schedules, in so far as there are currently proceedings in any County Court or any Business and Property Courts in England & Wales other than the Business and Property Courts in Manchester, be transferred to the Business and Property Courts in Manchester solely for the purpose of considering and, if thought fit, making the orders listed below;
3. The Applicant does ensure that a sealed copy of every order transferring any case to this Court and of every order which may be made as a result of this application be lodged with the Court having jurisdiction over each case affected by such an order for filing on the Court file relating to that case;
4. The time for service of this application shall be abridged to permit the application to be heard at such a time as this Court shall think fit;
5. Paragraphs 6 to 17 of this Order to take effect ~~on the date of this Order~~ at midnight on 16 February 2021;
6. Pursuant to Section 108 of the Act Gareth Hunt (the “**Applicant**”) be removed from his office as Liquidator of the companies identified in Schedule A, being in Creditors Voluntary Liquidation;
7. Pursuant to Section 108 of the Act, Annette Reeve (the “**Respondent**”) be appointed as Liquidator of the companies identified in schedule A being in Creditors Voluntary Liquidation;
8. Pursuant to Section 108 of the Act the Applicant be removed from his office as the Liquidator of the companies identified in Schedule B, being in Members Voluntary Liquidation;
9. Pursuant to Section 108 of the Act, the Respondent be appointed as Liquidator of the companies identified in schedule B being in Members Voluntary Liquidation;
10. Pursuant to paragraph 90 of Schedule B1 to the Act and Rule 12.36(1) of the Insolvency Rules 2016 (the “**Rules**”) the Applicant be removed from his office as the Administrator of the companies listed in Schedule C being in Administration;

11. Pursuant to paragraph 91 of Schedule B1 to the Act and Rule 12.36(2) of the Rules the Respondent be appointed as Administrator of the companies listed in Schedule C being in Administration;
12. Pursuant to Section 172(2) of the Act and Rule 12.36(2) of the Rules the Applicant be removed from his office as the Joint Liquidator of the companies identified in Schedule D being subject to a Compulsory Winding Up Order;
13. Pursuant to Section 168(3) & (5) of the Act and Rule 12.36(2) of the Rules the Respondent be appointed as Liquidator of the companies identified in Schedule D being subject to a Company Winding Up Order;
14. Pursuant to Section 298 of the Act and Rule 12.36(1) of the Rules the Applicant be removed from his office as the Trustee in Bankruptcy of the individuals identified in Schedule E being subject to a Bankruptcy Order;
15. Pursuant to Section 298 and 303(2) of the Act and Rule 12.36(2) of the Rules the Respondent be appointed as the Trustee in Bankruptcy of the individuals identified in Schedule E being subject to a Bankruptcy Order;
16. Pursuant to Section 7(5) of the Act the Applicant be removed from his office as Supervisor of the company voluntary arrangement identified in schedule F;
17. Pursuant to Section 7(5) of the Act the Respondent be appointed as Supervisor of the company voluntary arrangement identified in schedule F;
18. The creditors of the companies and the individuals listed in the Schedules be notified of the Order by advertisement in the London Gazette within 14 days of receipt of the Order by the Applicant and at the time of the next statutory reporting requirement for each case;
19. Pursuant to paragraph 98 of Schedule B1 to the Act and Section 7(4) of the Act, the Applicant be discharged from his liability in respect of any action of his as administrator of the companies or supervisor of the companies listed in schedules C and F with effect from 28 days after the relevant notice referred to in paragraph 18 above has been advertised, save in respect of any claim notified to the Respondent or the Applicant, by that date;
20. Pursuant to Rule 7.69, Rule 6.33, Rule 5.14 and Rule 10.83 of the Rules the Applicant shall be at liberty to apply to the Secretary of State for his release, as Liquidator (whether voluntary or compulsory) or Trustee in Bankruptcy of the companies and individuals listed in Schedules A, B, D and E with effect from 28 days after the relevant notice referred to in paragraph 18 above has been advertised, save in respect of any claim notified to the Respondent or the Applicant, by that date;
21. The Applicant and the Respondent shall notify the Secretary of State of the Order as soon as reasonably practicable after it is made;

22. All creditors of the companies and the individuals listed in the Schedules do have permission to apply to the Court, on notice to the Respondent, within 28 days of being given notice of the terms of the Order, for the purposes of applying to vary or discharge the order in so far as it affects the company or companies or individual's estates of which they are a creditor;
23. Pursuant to Rule 18.7 and Rule 1.3 and Schedule 5 of the Rules, the time for filing the progress report in the creditors' voluntary liquidations of the companies listed in Schedule A be extended to the date of the next scheduled report in each case;
24. Pursuant to Rule 18.7 and Rule 1.3 and Schedule 5 of the Rules, the time for filing the progress report in the members' voluntary liquidations of the companies listed in Schedule B be extended to the date of the next scheduled report in each case;
25. Pursuant to Rule 18.6 and Rule 1.3 of the Rules, the time for filing the progress report in the administration of the companies listed in Schedule C be extended to the date of the next scheduled report in each case;
26. Pursuant to Rule 18.8 and Rule 1.3 and Schedule 5 of the Rules, the time for filing the progress report in the compulsory liquidations of the companies listed in Schedule D be extended to the date of the next scheduled report in each case;
27. Pursuant to Rule 18.8 and Rule 1.3 of the Rules, the time for filing the progress report in the bankruptcy of the individuals listed in Schedule E be extended to the date of the next scheduled report in each case;
28. Pursuant to Rule 2.41 of the Rules, the time for filing the progress report in the voluntary arrangement of the company listed in Schedule F be extended to the date of the next scheduled report in each case;
29. Rule 3.65 of the Rules is overridden and dis-applied by Chapter 1A, of Part 6A of the Rules;
30. There be no order as to costs, save that the Applicants' costs of this application in the sum of £2,000 plus VAT, plus the Court fee of £155, and the London Gazette fee to advertise the Order, be charged as a cost or expense of the estates listed in the Schedule (each estate to bear an equal share, or such other share as the Respondent may decide but with no estate having to bear an amount exceeding 10% of the value of the available funds in the estates as at the date of this Order);
31. Immediately upon this Order taking effect, any cases listed in the Schedules which, pursuant to paragraph 2 above are transferred to the Business and Property Courts in Manchester be transferred back to the County Court or Business and Property Court from which they originated;
32. Compliance with Rule 12.38(3) of the Rules is varied so that the lodging of a certified copy of this Order, once sealed, with each Court is deemed to be compliant with that Rule;

33. Rule 4(5)(b) of the Insolvent Companies (Report on Conduct of Directors) Rules 1996 (SI 1996/1909) shall (if but for this order it would apply) not apply and the Respondent is not required to submit any reports in respect of the voluntary liquidations listed at Schedule A;
