All creditors of the companies and the individuals listed in the Schedules do have permission to apply to the Court, on notice to the Respondent, within 28 days of being given notice of the terms of the Order, for the purposes of applying to vary or discharge the order in so far as it affects the company or companies or individual's estates of which they are a creditor;
