

#### Structure, Governance and Management

A declaration of Trust registered 10<sup>th</sup> November 2012 and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006, incorporating the Memorandum and Articles of Association dated 18<sup>th</sup> May 2010, governs the activities of Trade Aid UK Foundation.

Trade Aid UK Foundation provides funding for the relief of poverty from income achieved under a deed of covenant from Trade Aid International Limited. No fundraising activities are undertaken where the public are requested to donate to the charity. Trade Aid UK Foundation is the charitable arm of Trade Aid International Limited.

#### **Achievements and Performance**

Since its formation, Trade Aid UK Foundation has been the charitable arm of Trade Aid International Limited, supporting various aid programmes around the world.

Funding is received from Trade Aid International Limited, the origins of which chart back to 1997 when Trade Aid UK, was formed by David and **Caroline Gerrie. This led to the establishment of Trade Aid International** Limited in 2002 when Nigel Dedman became an integral part of the founding team. The development of the Trade Aid UK Foundation in 2012 was a natural progression with the growth of the business. Funds are not sought from any other third party or private individuals.

In 2021/222, Trade Aid UK Foundation continued to feel the impact of the covid pandemic. Income from sugar sales has been affected by worldwide commercial decisions outside the influence of the In particular, as the world started to emerge from lockdown, surging demand inevitably saw the price of raw materials increase which has reduced profit margins leading to lower levels of donation. The effect has seen an income reduction of 60% from the initial forecast for 2021/2022. Consequently, the anticipated £36,000 in receipts dropped to £14,313 actual receipts over the 12-month reporting period.

Notwithstanding this, the Foundation has been able to direct its efforts to support to two key programmes, a new school building project in Anosy, Madagascar and the long-standing support to the Children's Refuge and Education Centre in Bihar, India. ## Summary

#### **Financial Review**

A review of the balance sheet and accounts, as at 31st March 2022, has taken place and the Trustees have agreed that they are an accurate record of the Foundation's accounts.

Trade Aid UK Foundation has maintained its unique position in that overheads are kept to a very bare minimum, which consist of accountant fees, legal fees and bank charges, thereby maximising the funding available for aid programmes. Receipts from Trade Aid International Limited meant that the Foundation was able to donate a total of £16,000 into two vital aid programmes in the year to 31st March 2022.

All funds held by the Foundation are unrestricted and that the Trustees act as custodians of such funds.

#### **Reserves Policy**

The unrestricted reserves at the balance sheet date were £8,001. The trustees aim to have unrestricted reserves of £500 to cover core expenditure for 6 months.

#### **Plans for Future Periods**

Trade Aid International continues to develop products and distribution of existing lines and, with this will continue a steady flow of income into the Foundation. It is therefore intended that the support to existing charities will continue, where appropriate, but also that new charities will be considered to receive grants for their work overseas.

#### **Declaration and Public Benefit Statement**

The Trustees have a duty to identify and review the risks to which the charity is exposed and to ensure appropriate controls are in place to provide reasonable assurance against fraud and error.

The Trustees believe that they have complied with their duty to have due regard to the guidance on public benefit published by the

Commission in exercising their powers and duties.

#### STATUTORY INFORMATION

Trade Aid UK Foundation is a private limited company, limited by guarantee, without share capital, and is exempt from using 'Limited'. It is domiciled in England and Wales, company registration number 07256229. It is a registered UK based charity, charity registration number 144621. It is a Public Benefit Entity.

#### 1. ACCOUNTING POLICIES

## Accounting convention

The financial statements have been prepared under the historical cost convention, and in accordance with Financial Reporting Standard 102 (FRS 102), the Companies Act 2006 and the requirements of the Charities Statement of Recommended Practice (Charities SORP (FRS 102)).

#### Key judgements and assumptions made

No key judgements or assumptions have been made that will have a significant risk of causing material adjustment to the carrying amounts of assets and liabilities within the next reporting period.

#### Going concern

The Trustees are of the view that the are no material uncertainties about the charity's ability to continue as a going concern for the foreseeable future as the charity provides grants according to the funding it receives and has negligible support costs. As such the accounts have been prepared on a going concern basis.

#### **Incoming resources**

All income is attributable to donations from Trade Aid International Limited. Trade Aid International Limited donates a minimum of 10% of its net profits to Trade Aid UK Foundation each quarter. These donations are included on the Statement of Financial Activities when the charity is legally entitled to the income and the amount can be quantified with reasonable accuracy.

#### Notes to the Financial Statements for the year ended 31 March 2022

#### **Resources expended**

Expenditure is accounted for an accruals basis and has been classified under headings that aggregate all costs related to the category. Where costs cannot be directly attributed to particular headings, they have been allocated to activities on a basis consistent with the use of resources.

#### **Expenditure on charitable activities**

The expenditure on charitable activities are grants which were given to third party institutions. The Trustees' Annual Report provides further details of the expenditure on charitable activities.

#### **Taxation**

The charity is exempt from corporation tax on its charitable activities.

#### **Fund accounting**

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees. Restricted funds can only be used for particular restricted purposes within the objectives of the charity. Restrictions-arise when specified by the donor or when funds are raised for particular restricted purposes. Further explanation of the nature and purpose of each fund is included in the Notes to the Financial Statements.





## SEKOLY PROGRAMME: EMAGNEVY

Improving Health and Education in rural Madagascar

April 2022

#### **SUMMARY**

#### Context

Madagascar remains one of the poorest and least developed countries in the world. Children bear the brunt of this burden, with over 70% of Malagasy children living in poverty. Despite 63% of children completing primary school, only 35.5% of children graduate from lower secondary school. These issues are amplified in rural schools across Madagascar's under-resourced Anosy region, where over half (51.5%) of children aged six to ten years have never attended school.

Moreover, 6,900 Malagasy children die annually from water, sanitation, and hygiene (WASH) related diseases. Insufficient, or even non-existent, WASH infrastructure in schools contributes to the transmission of diseases, and impedes academic achievement. In Madagascar, it is estimated that only 37% of schools have access to basic sanitation services, whilst 63% have no access to drinking water from an improved water source. Female students are further disadvantaged due to a lack of menstrual health and hygiene management (MHM) facilities, which prevents them from safely managing their menstruation in school, contributing to school absenteeism.

Project Sekoly as a Solution


SEED Madagascar's (SEED's) ~Sekoly Programme aimed to improve health and education in Madagascar's rural Anosy region by providing vital education and WASH facilities for 350 students and 10 teachers annually in Emagnevy Primary School. To complement this infrastructure, SEED has used a train-the-trainer approach to deliver WASH education sessions to teachers, enabling them to promote sustainable hygiene and sanitation practices, such as handwashing and safe MHM.

SEED has constructed a total of two classrooms, and made repairs to Emagnevy Primary School's existing school building. This additional space means students no longer need to share classrooms, and they are now able to attend full days of school in a safe learning environment. To reduce teacher absenteeism, housing was built for the headteacher, their family, and one further teacher.

SEED constructed three latrines and made repairs to one existing latrine. Additionally, two handwashing stations and a MHM facility were installed at Emagnevy Primary school. In partnership with Tatirano Social Enterprise, a 10,000-litre rainwater harvesting system was installed. When full, this system will provide clean drinking water to students, teachers, and the local community for up to two months without needing replenishment. To empower the local community to independently sustain the WASH infrastructure improvements, a WASH management committee has been established and all 10 teachers have been trained to lead WASH education.

Construction activities for the two-classroom school building at Emagnevy Primary School were completed in January 2022. The foundations were excavated and built using concrete and reinforcing bar structural support. Floors and walls were erected using cement blocks with wooden beams installed to support the tin roofing. Windows and doors were made on site and fitted before painting activities commenced. SEED finalised repairs to the existing school building in February 2022 and provided 70 desk-benches for students. Each classroom has been furnished with a blackboard, lockable cupboard, and teacher's chair and table. The provision of education infrastructure at Emagnevy Primary School will enable 350 students to attend full days of lessons in safe and high-quality learning environments.

#### **Teacher Accommodation**

The construction of the three-room teachers' house was completed in February 2022 and is providing the Headteacher, their family, and one additional teacher with free, safe, and reliable accommodation. By integrating furnished teacher housing into school projects, teacher retention is

improved and the school attracts higher-quality teachers, both enhancing school management and security, and minimising staff absenteeism.




The completed school building and teacher accommodation at Emagnevy Primary School.

#### **WASH Facilities**

The construction of three gender-segregated, ventilated improved pit (VIP) latrines, and repair of one existing latrine at Emagnevy Primary School are complete. SEED installed two handwashing stations, equipped with WASH behavioural 'nudges' and an informative mural, prompting students and teachers to practice good hygiene. In collaboration with Tatirano Social Enterprise, SEED installed a 10,000-litre rainwater harvesting system that provides the school and community with a two-month supply of clean water when full, before needing replenishment. The students and community have access to clean drinking water, reducing the transmission of WASH-related illnesses. Additionally, a MHM facility was constructed, with access to running water from the rainwater harvesting system, empowering female students to manage their menstruation in school with privacy and dignity.

The provision of WASH facilities in Emagnevy will help promote safe WASH practices amongst the 350 students and 10 teachers annually, through reliable access to latrines, handwashing stations, MHM facilities, and drinking water.

#### **WASH Education and Capacity-Building**

To complement the improved WASH infrastructure, SEED has trained 10 teachers at Emagnevy Primary School to deliver WASH education sessions to a total of 350 students annually. Additionally, a WASH committee, comprising of teachers and parents, has been established to maintain the new infrastructure. SEED delivered WASH education training to WASH committee members and teachers

in Emagnevy, covering topics such as handwashing, latrine use, latrine maintenance, and water treatment. These activities promote good WASH practices amongst students, and build the capacity of the community to sustainably manage the new WASH facilities.

#### Sekoly Maintso

The production and transportation of building materials to school sites produces carbon dioxide emissions that contribute to climate change, disproportionately impacts communities such as Emagnevy. Project Sekoly Maintso (Green School in Malagasy) offsets the carbon footprint of the Sekoly Programme through carbon offsetting.

The emissions produced during the construction of Emagnevy School are calculated at 67,966 kgCO<sub>2</sub>e. In March 2022, SEED planted 325 *Acacia mangium* trees in Emagnevy in a carbon offset plantation, which will offset the emissions over a period of 10 years. An additional 325 *Acacia* trees have been planted in a resource use plantation, providing the community with a sustainable wood resource. Given the high demand for wood in the community, the creation of a resource use plantation will ensure that the trees from the offset plantation are protected. Alongside this, 144 fruit trees of six different species – including custard apple, papaya, and mandarin have been planted between the plantations and behind Emagnevy Primary School. These fruit trees will provide a sustainable source of nutrition for the school students as well as the wider community. To protect the plantation sites, signboards have been placed and a 'living' fence using regenerative native species has been planted around the site. Additionally, the students of Emagnevy Primary School received education on the importance of protecting the environment.

#### **Community Handover**

The handover ceremony for the school was held in mid-September 2022, after students had returned from their summer holiday. Responsibility for maintaining the schools and the equipment

was formally transferred back to Emagnevy community. The ceremony involved speeches, a community blessing of the new buildings, and a traditional Zebu sacrifice.

#### SUSTAINABILITY AND MONITORING

#### Sustainability

The Sekoly Programme ensures sustainability through complimenting the smart, durable design of our infrastructure with capacity building of the school community, enabling them to enact and sustain positive WASH behaviours. The school buildings and WASH facilities have been designed to withstand extreme weather conditions and require minimal maintenance. SEED empowers students and teachers with the knowledge and tools to sustain new infrastructure and positive WASH practices. A train-the-trainer approach is used to build the capacity of teachers so they can deliver interactive WASH education sessions. Operating independently of SEED, teachers will deliver these education sessions to the students annually.

Monitoring, Evaluation, and Learning (MEAL)

Over the duration of the project; SEED has monitored the progress of activities at Emagnevy through regular visits and departmental reviews. A baseline assessment of WASH knowledge and behaviours was carried out before construction began, and an endline survey was conducted upon project completion. The RAG-system (red-amber-green) was used to track activities and the progress of project outputs was regularly updated and reviewed by the management team. Follow-up visits, including observational monitoring by SEED staff, will be carried out within six months of project end. During these visits, SEED staff will assess the ongoing maintenance of WASH infrastructure and the adoption of improved WASH practices among teachers and students.

#### **FINANCES**

The project was completed under budget. The repair of both the existing school infrastructure, and latrine facilities at Emagnevy Primary School required less metal sheet roofing, cement, and wood resulting in underspend across construction material lines. In January 2022, SEED conducted a risk assessment of the existing groundwater well at Emagnevy Primary School and deemed it unsafe to use. As a result, reduced expenditure was required across cement, rebar, and handpump lines for the well repair on site.

The underspend of £5,412.96 will kindly be allocated to the next education infrastructure project, Programme Sekoly: Sarisambo. If you would like more information about this upcoming project, please do not hesitate to get in touch.



## REPORT FROM TSN

Everyone at TSN would like to extend their thanks to Children on the Edge and their kind donors for supporting us over the past few years.

Together we have made a change to the lives of the young children, especially girls in our community.

We acknowledge that this is the last year of our relationship and we have achieved so much. This is true, even in this final 12 months as we have made the transition into new communities with our work

As we write, the work we do now covers three communities and a total of 90 children regularly attend our services. The three communities are called Banmankhi, Khushkibag and Rahmat Nagar.

In Banmankhi we help 12 boys and 14 girls. In, Khushkibag wen have 14 boys and 16 girls and in Rahmat Nagar we have 15 boys and 19 girls. In all locations we have run an education programme that consists of basic education, general knowledge, indoor games and cultural activities. This daily activity is helping the children improve their behaviour from basic hygiene skills to understanding the world they live in and how to make progress as well as basic academic skills.

In the years of our work together we must also recognise the great changes that have been made to the lives and livelihoods of young women.

The communities where our students live are the subject of many risks, especially for teenage girls from trafficking and the sex trade. Providing training in tailoring and the gift of a sewing machine to over a hundred young girls has helped give them and their entire families a new life.

This intervention has on many occasions enabled entire families to move out of brothel communities. As we move to new communities, we feel proud of what we have been able to achieve together with your

kind support.










## LEARNING MATERIALS DISTRIBUTION
