**1 Statutory information**

Pru Tech Solutions Ltd is a private company, limited by shares, registered in England and Wales, registration number 11372208. The registered office is 27 FINEFIELD WALK, SLOUGH, BERKSHIRE, SL1 2QR, ENGLAND. The company is in the process of being wound up.

**2 Directors' advances, credit and guarantees**

Included in creditors a sum totaling £49,276.30 (2020: £45,841) was due to the directors of the company.

**3 Average number of employees**

During the year the average number of employees was 2 (2020: 2).

For the year ending 31 May 2021 the company was entitled to exemption from audit under section 477 of the Companies Act 2006 relating to small companies. The members have not required the company to obtain an audit in accordance with section 476 of the Companies Act 2006.
