Company activities and impact

Safety In Music CIC works towards reducing serious organised crime and harms being caused to vulnerable children, young people, and adults. We develop innovative educational and vocational creative arts programmes which enable vulnerable young people and adults to contribute significantly to the music industry. We use key industry leaders and highly skilled practitioners to deliver interactive workshops using the power of music, lyrics, dance, games, and video production. During 2021/2022 Safety In Music CIC worked with The Home Office, West Yorkshire's Violence Reduction Unit (VRU) and Kirklees Council. We provided creative industry opportunities for young people vulnerable to knife crime and gangs and worked to reduce violence against women and girls. We focused on: 1) Music production, lyric writing and film/video production programmes.2) Youth violence prevention programmes. The final products were shared and distributed by The Home Office, West Yorkshire Violence Reduction Unit, communities, councils and more.3) #SIM Young People Change Makers Project with the aim to create young leaders to be the voice for other young people and lead on local and national campaigns to counter act serious organised crimes, youth violence and exploitation.4) Mentoring programmes for vulnerable young people.

Consultation with stakeholders

Safety In Music CIC's stakeholders are identified as our trainees and partners and they are the young people, parents and carers as well as The Home Office, West Yorkshire Police and Crime Commissioner, West Yorkshire Violence Reduction Unit, West Yorkshire Mayor and Deputy Mayor, Kirklees Children's Rights Services, Kirklees Council, Kirklees Foster Carers, Huddersfield University, Leeds Beckett University, West Yorkshire Combined Authority, University and College placement students and Safety In Music CIC's Young Ambassadors Leaders. We hold regular meetings and consultations during and after our programmes delivery to ascertain and evidence the need to continue providing Safety In Music CIC's creative industry programmes. We also track, monitor and support passed learners and run surveys via Safety In Music CIC's web and social media pages. Safety In Music CIC works in close partnership with West Yorkshire's Violence Reduction Unit and co-production partnerships to support research and gather intelligence about hot spot areas in West Yorkshire where there is a priority need to deliver youth violence prevention programmes.
