The activities have been carried out with a lottery fund which has paid for leadership training and personal coaching for each candidate engaging with a programme specifically designed for minority women within the Greater Manchester region.

Consultation has also taken place with the ILM and ICF in addition to the Coach Supervisor conducting focus group consultation with the coaches and more are scheduled upon completion for learning to be absorbed into planning going forward.

Consultation with the women is a constant between themselves and their coach – which is reacted to where required with amendments by the Directors. Progress reports with the women and the Directors is also ongoing to assist appreciation of the support required and the facilitation of this requirement on a one to one or group basis.
