Pursuant to Chapter 2 of Part 13 of the Companies Act 2006, the directors of the Company propose that the resolutions below are passed as special resolutions (Special Resolutions).

SPECIAL RESOLUTIONS

- 1. THAT the rights attaching to the Ordinary shares of £0.01 each in the Company (Shares) be varied so that before 31 December 2023 the Company shall be entitled to give to any holder(s) of Shares a notice of conversion (Conversion Notice) in respect of all or any part of the Shares registered in their name to convert said Shares into S1 shares of £0.01 each in the Company.
 - (a) The Conversion Notice shall state:
 - (i) the number and class of Shares to be converted;
 - the class of shares (S1 shares) into which the Shares are to be (ii) converted;
 - the date for conversion or if no date is stated then the date for (iii) conversion shall be the date of the giving of a Conversion Notice.
 - (b) Conversion of the Shares shall take place at the registered office for the time being of the Company on the conversion date specified above if the Conversion Notice is accepted by the holder(s) of Shares to whom it was sent and, for the avoidance of doubt, if the Conversion Notice is not accepted by the holder(s) of Shares to whom it was sent, then no conversion shall take place.
 - Each holder of Shares to be converted that accepts a Conversion Notice (c) shall on or before the date for conversion deliver to the Company the certificates in respect of the shares to be converted for cancellation and the Company shall issue new share certificates at the rate of one fully paid S1 share in the Company (as per the Conversion Notice) for each Share and if the holder of any Shares to be converted fails to comply with their obligation

to deliver up the certificates of those Shares at the time of conversion, the Company may elect either:

- to waive that obligation and proceed immediately with the conversion of those Shares, upon such (if any) additional terms as to indemnity as the Company may reasonably require; or
- (ii) to defer the conversion of those Shares until such time as certificates can be produced in respect of them.
- (d) The S1 shares in the Company shall have such rights as set out in the articles of association of the Company.
- 2. THAT the regulations attached to this written resolution be and are hereby adopted as the articles of association of the Company in substitution for, and to the exclusion of, the existing articles of association with immediate effect.
