We are disseminating skills, creating communities, instilling a passion for creativity and supporting networks through shared learning and making.

Some specific examples of community projects:

- Running a number of workshops with homeless people in collaboration with Coastline Housing.
- Running creativity for wellbeing classes for NHS staff in partnership with Arts Well.
- Delivering after school pottery classes in collaboration with Cornwall Neighbourhoods for Change (CN4C) who are also involved in our reporting to funders.
- Running a tiling project with Girls Assemble CIC, encouraging girls to become interested in construction skills.
- Hosting and running a number of community open days to engage local people with the building renovation and embed them in our creative community.

Our courses benefit the mental health of attendees as well as their upskilling in ceramics, glass and jewellery making.

Some quotes from course and workshop attendees:

- "Without any intention to join for anything other than making things, I soon discovered that community-based art-making improved my stress levels."
- "Ceramics helps me to enter into a 'flow state' and as a result and as a result it's helped me through significant periods of stress in my life as well as being a valuable creative outlet."
- "Creativity feeds the soul and we need it especially in these difficult times."
- "Although I joined the jewellery making group with some trepidation at the age of 82 I
 found working with likeminded people of a wide age range gave me the confidence that
 I could create something worthwhile."

We ran a series of local community and family open days to engage the local community in the building renovation. Community members made tiles which become part of the mosaic in the new accessible toilets to embed their ideas into the renovated building.

Create (Cornwall) CIC Director Angela Hatherell is on the Camborne Town Deal Board to ensure that the Contemporary Crafts Hub is strategically aligned with the other Town Deal projects and overall the Town Deal funding can be put to best use to benefit the people of Camborne. She is also on the communications sub-committee to help ensure the people of Camborne and the wider population are aware of the work that the Town Deal funding is investing in. Create CIC is in receipt of funding from DLUHC for capital works to renovate the building and make creativity accessible to anyone in the town, through Camborne Town Deal. This requires quarterly reporting on progress, outputs and outcomes.

Create CIC is in receipt of funding from ERDF for capital works to renovate the building and make creativity accessible to anyone in the town, through Community Led Local Development (CLLD). This requires regular reporting on progress, outputs and outcomes.

We collect feedback and have had repeat business from representatives (staff and students) from local colleges and universities informing further collaborations.
