

1 Accounting policies

Basis of preparation

The accounts have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

The consensus reported in the draft Abstract 49 of the Urgent Issues Task Force of the Accounting Standards Board issued on 10 May 2012 has been adopted in the production of these accounts

The accounts for previous periods were produced on the basis that service charges levied on residents were the property of the company. Accordingly the reserves brought forward at 27 March 2012 have been restated as have the results for the previous year

Turnover

Turnover represents the reimbursement, by residents, of funds expended on their behalf

Cost of sales

Cost of sales represent the value of goods and services procured on behalf of the residents of flats in a property known as Jacinta, Westminster Road, Milford on Sea, Hampshire

The directors consider that these transactions were undertaken as principal, and not as a disclosed agent for the residents

2 Funds held on trust

The company holds service charge money in bank accounts in its name on trust for the tenants of Jacinta in accordance with section 42, Landlord and Tenant Act 1987. These amounts are not shown in the balance sheet as they do not belong to the company

The total of service charge money held amounted to £30,225

3 Freehold property

The company owns the freehold title to the property known as Jacinta, Westminster Road, Milford on Sea, Hampshire

Residents hold their flats on 990 year leases
