Property charged pursuant to a Legal Charge in favour of Nationwide dated 27.04.2005

The Company with full title guarantee charges to Nationwide:

- 1. By way of legal mortgage the freehold & leasehold properties on attached schedule (Title Numbers see attached schedule) (the "Property") and all buildings, assets of whatsoever nature, apart from land and buildings ("Fixtures") (including trade Fixtures) and fixed plant and machinery from time to time on such property together with all estates, rights, title, options, easements and privileges appurtenant to, or benefiting, the same including all beneficial interests and rights of the Company in the Property and in any proceeds of sale or disposal of any part of the Property.

- 5. By way of an assignment all monies from time to time payable to the Company under or pursuant to all present and future contracts or policies of insurance effected by the Company or to which the company is entitled (including the refund of any premiums).

- B. The Legal Charge secures further advances.
- C.
