**1. STATUTORY INFORMATION**

Marcia's Kitchen Limited is a private company, limited by shares, registered in England and Wales. The company's registered number is 07979112 and its registered address is Unit 5 The Dove Centre, 109 Bartholomew Road, London, England, NW5 2BJ.

**2. AVERAGE NUMBER OF EMPLOYEES**

The average number of employees during the year was 1 (2020 - 1).

The company is entitled to exemption from audit under Section 477 of the Companies Act 2006 for the year ended 30 September 2021.
