Our community of professional theatre and performance artists rely on income from performances and arts events, and were greatly affected by changes to programmes and cancellations. Residence (Bristol) CIC reacted to the situation by providing online support to its members, although the company's conventional activities were pared back to a minimum.

The company regrouped during support activities and meetings. The focus of these meetings was on making longer-term post-pandemic plans, and on coping strategies to deal with the immense pressure our members saw themselves under. The CIC also continued to invest in its online presence.
