# NOTES TO THE FINANCIAL STATEMENTS FOR THE PERIOD ENDED 31 DECEMBER 2022

#### 1. Principal activities and basis of accounting

The Company was incorporated on 28 May 2021. It has not traded since the date of its incorporation and has made neither profits not losses during the current or prior period.

The financial statements of Hoxton Hotel Operator Limited have been prepared in accordance with International Financial Reporting Standard 101 'Reduced Disclosure Framework' (FRS 101) and the Companies Act 2006. The Company has taken the exemption to retain its current accounting policies for reported assets and liabilities as it is a dormant company.

The Company is an immediate subsidiary of Hoxton Holdings BV, a company incorporated in the Netherlands and it's the ultimate parent, PPHE Hotel Group Ltd, incorporated in Guernsey.
