We have put on four festivals since we created Festival of The Girl CIC. The first was Sat 5th October 2019 in Tower Hamlets for 150 girls. The second on Sunday 11th October 2020 was a free virtual festival where over 2000 girls signed up. The third on Sunday 10th October 2021 was a free virtual festival where over 3500 girls signed up. In 2022 we were live again to over 1100 girls and their families at the Business Design Centre in Islington.

Our festivals are aimed at girls aged 7-11 years old, for whom there is nothing else like this.

Through our virtual/live festivals, held in October for International Day of The Girl, we're tackling gender stereotypes head-on by exposing girls to role models and experiences they might not get in everyday life. With activities designed specifically to get girls thinking about their own future and realising the vast opportunities available to them, they build their confidence and expand their dreams. This creates a resilient foundation before girls start secondary school and are surrounded by even more prevalent stereotyping and higher social media exposure. We also invite boys and parents/carers to join in, bringing everyone's attention to tackling unnecessary stereotypes.

We have received huge amounts of positive feedback from the girls who attended (and their parents), and this year not only will be back at the Business Design Centre again for over 1500 girls / families we are also running a local community project, an evening adult event and running workshops at Camp Bestival Dorset and Shropshire.


