Box Positive CIC delivers non- contact boxing sessions for people with Parkinson's and for some people with other neurological and mental health conditions. These other conditions have included; Dementia, Stroke, Traumatic brain injury, Bells Palsy and depression

Sessions are based on research evidencing the benefits of exercise, activity and specific movements that counteract Parkinson's symptoms. Classes and individual sessions offer people an opportunity to take constructive action against Parkinson's symptoms. Currently people are prescribed medication to help manage symptoms although exercise has now been proven to slow disease symptom progression. Non-motor symptoms include apathy and people can find it difficult to engage in exercise classes due to low levels of motivation and low mood that can result from being diagnosed with an incurable, progressive condition. Box Positive offers an opportunity for people to work together within a social setting and take part in a fun programme that is led by Charles Delve who is an Occupational Therapist, former England boxer and prior Head Coach at Droitwich Amateur Boxing Club.

The Covid pandemic initially presented the community with a number of challenges. In order to overcome these challenges Zoom was introduced. Box Positive also formed a partnership with Sport Parkinson's. This organisation was set up to spread awareness about the condition and encourage people that are living with Parkinson's to stay active. Charles provided free sessions as part of an online 8 week trial to keep people active using an online programme where people could choose weekly classes that they wanted to attend. One positive of the Zoom sessions have been that Box Positive has been able to reach people living in Scotland, Wales, North and South of England, even Germany so the community has in fact grown as a result of the pandemic.

Charles continued seeing some people at their homes, this included people that were unable to mobilise independently and needed hands on support with their exercise routines.

Contributing member of the Parkinson's Excellence Network this is a network of healthcare and fitness professionals that share best practice and inform guidelines for people that work with people with Parkinson's.

Supported the development of a social support group for partners of people with Parkinson's. This support group has designed leaflets for people with Parkinson's to take in to hospital to inform hospital staff about the importance of taking medication at the correct times.

Set up a participant led committee and steering group to advise on CIC direction.

Contributed towards maintaining the facility at Droitwich Amateur Boxing Club a Community Amateur Sports Club by paying a regular fee to hire the venue, cleaning the equipment before and after sessionS.

Box Positive has supported the development of a social support group for partners of people with Parkinson's.

Set up a participant led committee and steering group to advise on CIC direction. During the pandemic the group met outside and collaboratively agreed how to take the company forward and keep all participants enthused and engaged.

Sent out a monthly newsletter and invite contributions from Box Positive members.

Stakeholders also include the gyms that are hired as venues for the programme. Box Positive has brought in new revenue to Droitwich Boxing club and improved the clubs reputation as the club is now seen as an inclusive setting that offers a centre for competitive boxers, people that would like to keep fit and that people with disabilities are welcome.

Group and one to one sessions integrate evaluation and an opportunity for stakeholders to give feedback on how to further improve the reputation of the organisation.
