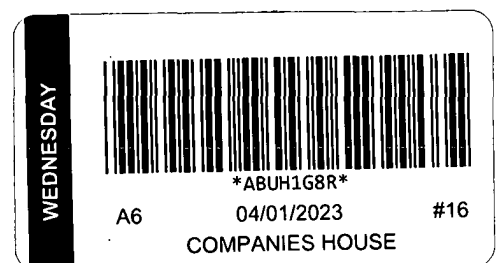

**3 Average number of employees**


During the year the average number of employees was 1 (2021: 2).
