### **INTRODUCTION**

The Company was placed into members’ voluntary liquidation on 18 October 2018 when Laura Waters and Robert Lewis were appointed Joint Liquidators (the Liquidators).

We are required to provide you with a final account on the conduct and outcome of the liquidation. This account is for the period 18 October 2018 to 27 September 2019 and also serves as a progress report from 18 October 2018 to 27 September 2019.

We are also required to give you certain information about the Company and the Liquidators; this information is attached as Appendix A.

We attach as Appendix B a summary of our receipts and payments for the liquidation.

### **REPORT ON THE LIQUIDATION**

#### **Realisation of assets:**

The directors’ Declaration of Solvency showed that the Company had no assets.

#### **Settlement of liabilities:**

The directors’ Declaration of Solvency and the Company’s records showed the Company had no liabilities.

After our appointment we published a notice in the London Gazette inviting any unknown creditors to send in their claims. No such claims were received.

#### **HMRC:**

After our appointment, we wrote to HMRC to inform them of our appointment and to request details of any outstanding liabilities. HMRC have confirmed that the Company has no outstanding liabilities and they have no objections to the closure of the liquidation.

#### **Distributions to shareholders:**

During the liquidation, we made a sweeper distribution only consisting of any other assets held by the Company to the Ordinary shareholder.

### **OUR FEES AND EXPENSES**

At the time of our appointment, a resolution was passed for us to be paid by reference to the time properly given by us and our staff in dealing with the liquidation. Anglo American Services (UK) Ltd has met our fees and expenses for the Company and 14 connected UK liquidations.

Our time costs incurred to 26 September 2019 during the liquidation in relation to the Company and 14 connected UK liquidations totalled £85,229, of this time, £1,800 has been raised and settled.

#### **Liquidators’ expenses:**

During the liquidation we have incurred category 1 disbursements of £459 plus VAT relating to the Company and 14 connected UK liquidations.

This concludes our account.
