

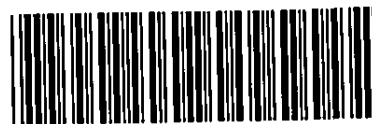


DIRECTORS' INTERESTS
