The sheriff, having considered the foregoing petition by the joint liquidators of Buckie Taxis Limited, dispenses with any service, intimation or advertisement of said petition or any deliverance following thereon; dispenses with a remit to an independent accountant on the joint liquidators intromissions; approves the joint liquidators whole actings and intromissions; releases the joint liquidators, Kenneth Wilson Pattullo and Kenneth Robert Craig of their whole actings, intromissions and management as joint liquidators of Buckie Taxis Limited; authorises the joint liquidators to retain the balance of funds in their hands at the sum of £9418.00 plus any statutory interest to account for their remuneration as per time cost analysis; being satisfied that the realisable assets of the Company are insufficient to cover the expense of the winding up, orders the dissolution of the said Buckie Taxis Limited; in terms of section 204 of the Insolvency Act 1986 as applied by section 112 of the Insolvency Act 1986, ordains the joint liquidators to notify the Registrar of Companies and all creditors who have lodged claims of the early dissolution in terms of section 204(4) of said Act as applied by section 112 of the Insolvency Act 1986; and dispenses with the need to convene a final meeting of creditors.
