Oasis Charitable Trust is the founding member and guarantor. CCUKCP does not have share capital. Directors are appointed by a majority of Directors/Trustees or by the Guarantor.

The Directors delegate duties for researching and completing funding applications to a group comprised of members of the Church community and staff. Administration duties are supported by Oasis

#### 13 Fund accounting

Restricted funds are funds which are to be used in accordance with specific restrictions imposed by donors which have been raised by the company for particular purposes. The cost of raising and administering such funds are charged against the specific fund.
