Provision of bus services in the South Oxfordshire, West Berkshire and Reading Borough Council areas. Due to the coronavirus pandemic, services were reduced as demand was down considerably on pre-pandemic levels. Furloughed salaries were covered by the government's Job Retention Scheme, which ended in September 2021.

Our routes are targeted at communities where commercial operators have withdrawn their services. The services have been operated entirely without local authority subsidies, except for a small grant from two Parish Councils, and from September 2021 a grant towards the running costs of one service from Oxfordshire County Council (using section 106 buildings development money).

A total of 12,730 journeys were recorded (up from 12,347 in 2020 due to coronavirus) of which the vast majority (12,076) were concessionary pass holders, for which the company was reimbursed by local authorities at various rates per journey. From March 2020 these reimbursements were based on 2019 patronage levels due to the severe effect the coronavirus had on passenger numbers, adjusted from April 2021 to take into account the pro-rated mileage operated. This resulted in a small operating surplus which has been used to partially offset the carried forward losses incurred in 2017-2019.

These services continue to provide a vital link for those who otherwise would not be able to get out and about independently, plus a more environmentally friendly alternative to car driving in the area.
