PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

The company collects data from available archive sources about the people of Keighley and the Worth Valley area who served in wartime, and creates biographies of these people for our archives. We disseminate this information through our online facilities and social media accounts and with displays at public exhibitions and events.

Through the year we continued to carry out our research based on individuals from our district. We continued the online engagement of the people who follow our social media accounts and had a number of very interesting donations of information which have been deposited in our archives.

On 2nd July 2022 we had a stand at Oakworth Gala and on 9th July 2022 was the Cross Roads Gala. These were well attended and local people were very interested in our research work, reflected in comments in our guestbook at both events. 31st July was Yorkshire Day and we supported Keighley Town Council by attending with a stand and display.

On the 3rd September 2022 we attended Keighley Show and 10th September 2022 it was Heritage Open Day at Keighley Library and we had a lot of interest at both events with people coming in with archive material for us to scan and discuss with them.

In November 2022 we received a grant of £2939 from Keighley Town Council and spent several weeks in the new year, purchasing new gazebos and display equipment to replace some items worn out over the years and increase our ability to display biographies of people we have researched. This was supported on our website by a large increase in blog posts about these individuals. Our original gazebo was donated to a local volunteer run mental health support group, who were very pleased to receive it.

In December 2022 we obtained a £255 grant to purchase an oral history recorder, and on 9th February 2023 we used it for the first time to interview a local lady about her life, including her experiences during WW2. In January 2023 we had attended the commemoration of six Canadian airmen who died in an aeroplane crash in January 1944 and put a display up featuring their lives. This was very well received as usual. The lady we interviewed came along with us as our guest and this was her first attendance for a long time.

We were asked by Keighley Town Council to attend their Community Showcase event which celebrates the grant funding given to many local voluntary groups. We were very pleased to attend this prestigious event and happy to show our gratitude towards Keighley Town Council in return for their support for us over many years.

Our final event of the financial year of 2022/2023 was at the Riddlesden Gala on 24th June and as with other similar events, it was well attended and we had some good comments in our guestbook about our research work and displays. This year was the first after the Covid pandemic and people seemed pleased to be able to interact face to face with us again after so long.



The stakeholders are the local people of Keighley and the Worth Valley. As usual, many of them have contacted us as a direct result of our online articles. We get new contacts by phone, email and on social media on a regular basis and this has continued steadily with new information coming in about people whom we haven't yet researched. This new information is added to our database and we work proactively to research these new names 'on the spot', add them to our archive, and feed the information back via social media and by email, to the people who have contacted us.

We have continued to engage with our stakeholders through our social media outlets and on our website. This of the year saw the lifting of some COVID-19 restrictions, enabling some restricted exhibits and events. Feedback came from personal comments and written messages through our social media and the comments on our website, plus visitor's comments at these reduced events.
