## 1. Introduction

The purpose of this report is to detail the acts and dealings of the Liquidator and it should be read in conjunction with previous reports to creditors.

I was appointed Liquidator of the Company on 13 April 2022.

Since 1 January 2021, I have been licensed to act as an Insolvency Practitioner in the UK by the Institute of Chartered Accountants in England and Wales and prior to that date I was licensed by the Insolvency Practitioners Association. I can confirm that there has been no change in office-holder since the date of the liquidation.

Statutory information regarding the Company is provided at Appendix 1.

## 2. Progress

## **Administration**

A summary of the Liquidator's administrative duties are detailed at Appendix 2 of this report. These actions contribute to the efficient running of the estate and are required by statute and regulation. There is no direct financial benefit for creditors.

#### **Assets**

Actions taken in relation to assets may have a direct financial benefit for creditors by way of a distribution to creditors after settlement of properly incurred costs.

According to the Statement of Affairs lodged in these proceedings, the assets of the Company had an estimated value of £35,000.00, which comprised principally of cash at bank.

The progress of realisation of these assets for the period of this report is detailed below.

#### Leasehold Improvements

The Statement of Affairs listed leasehold improvements with a book value of £465,000.00. During the period I have sought additional information in respect of this asset and note it's inclusion in the Company's last filed accounts to 30 December 2020. Having queried the same with the Director, this asset is in relation to the concreting of the Company's leased premises yard.

I am continuing to seek further information around this asset and the circumstances under which works were carried out, however at this time any realisation in respect of the same remains uncertain.

## **Fixtures and Fittings**

The Statement of Affairs listed fixtures and fittings with a book value of £3,200.00. Given the nature of these assets and the costs associated with conducting any sale, it was not considered in the commercial interest of creditors to take any further action in respect of the same. No realisations will be made in respect of this asset.

### Cash at Bank

During the Liquidation I have received the sum of £25,400.00 in respect of funds held in the Company bank account.

#### **Bank Interest**

During the Liquidation I have received the sum of £104.35 in respect of interest which has accrued on the balance of funds held in the Liquidation bank account.

## 3. Investigations

Actions taken in relation to investigations will only have a direct financial benefit for creditors if actions or assets are identified for realisation into the estate. The Liquidator has a statutory and regulatory duty to complete investigations into the conduct and affairs of the Company and its directors.

An initial investigation into the Company's affairs was undertaken to establish whether there were any potential asset recoveries or conduct matters that justified further investigation. These investigations included reviewing the changes in the Company's assets and liabilities in the period from its last accounts for the financial period ending 30 December 2020 to the date of Liquidation and a review of the Company's bank statements.

I have also considered the Company's use of Covid support schemes and its entitlement to the same.

My initial investigations have identified some matters of interest which warrant further explanation by the Director of the Company. These queries relate to transactions with the Company's director, connected parties, and with unknown business purpose in the period leading up to the liquidation as well as unexplained changes in the Company's assets between the period of the last accounts and the date of the liquidation and excessive cash withdrawals. It is currently uncertain whether the transactions identified will result in realisations, however the relevant action will be taken on receipt of further information in respect of the same.

I am also continuing to pursue documents which will allow me to progress my investigations further in this matter. A review of these documents will be conducted on receipt to establish whether there are any potential asset recoveries or conduct matters in the liquidation.

I have instructed Freeths Solicitors to assist me in my investigations and additional details of their instruction and costs are detailed later in this report.

A report on the conduct of any individuals, who have been directors of the Company in the three years prior to the insolvency, is required to be submitted to the Secretary of State within three months of my appointment. I confirm that this has been submitted, however the content of this report is confidential.

## 4. Costs and Expenses

A Receipts & Payments Account for the period covered by this report and the liquidation in its entirety is enclosed at Appendix 3. Receipts relating to asset realisations have been detailed in the progress section above. Information in relation to the costs and expenses of the liquidation are detailed below.

## **Pre-Appointment Costs**

At the virtual meeting held on 13 April 2022 it was resolved that the Liquidator's fee in relation to the assisting the directors with preparing the Statement of Affairs be fixed at £8,000.00 plus VAT. I have drawn all of these costs.

The fixed fee is considered to be fair and reasonable as it provides creditors with certainty as to the level of the fee to be charged for this work. Further, the Liquidator considers that the fee is commensurate with the amount of work required to carry out these activities in their professional experience.

#### Liquidator's Remuneration

Numerous activities have been undertaken in administering the liquidation. A summarised list of these activities is attached at Appendix 2 for your information.

On 28 February 2023 creditors agreed the basis upon which I was to be remunerated. A resolution was passed that I be remunerated on the basis of time properly spent by me and my staff in attending to matters arising in the administration of the liquidation. A fee estimate of £25,800.00 was provided when seeking the resolution.

My time costs for the period 13 April 2022 to 12 April 2023 total £11,645.00 represented by 37.00 hours at an average hourly rate of £314.73. A breakdown of these time costs is enclosed at Appendix 4.

The sum of £11,145.00 has been drawn to date.

As set out above, a fee estimate was agreed by creditors to limit my liquidator's fees to £25,800.00 plus VAT.

It is not anticipated that time costs will exceed the amount provided in the fee estimate.

## Liquidator's Expenses

My category 1 expenses paid for the period up to the end of this report are detailed below. The basis of these expenses were approved at the creditors' decision procedure held on 28 February 2023. I have drawn all of these costs.

### **Other Professional Costs**

#### **Solicitors**

Freeths Solicitors were instructed to assist me with my investigation matters during the Liquidation. Their costs have been agreed on the basis of their standard hourly charge out rates, plus disbursements and VAT.

The total estimated time costs that are likely to be incurred in this matter are in the range of £1,000.00 to £2,000.00 It is not possible for me to give more accurate indication of the total anticipated time costs to be incurred by solicitors in this matter as it is dependent on the conduct of the parties.
