PARTIES

- DONNINGTON LAND & PROPERTY LIMITED (company registration number 02796034) whose registered office is at care of Haines Watts Advantage, 87 Castle Street, Reading, Berkshire RG1 7SN (the Mortgagor);
- (2) GRUNDON WASTE MANAGEMENT LIMITED (company registration number 04245965) whose registered office is at Thames House, Oxford Road, Benson, Wallingford, Oxfordshire, OX10 6LX (the Lender); and
- (3) MARK NORGATE of New Warren Farm, Warren Road, Newbury, Berkshire, RG14 6NH (the Borrower).

WHEREAS

- (A) The Lender has agreed, under the Restated MN Facility Agreement, to provide the Borrower with loan facilities on a secured basis.
- (B) The Mortgagor owns the Property which the Mortgagor intends to develop with other land.
- (C) This Deed provides security to the Lender for the loan facilities made or to be made available to the Borrower under the Facility Agreement.

IT IS HEREBY AGREED

1 Definitions and interpretation

1.1 Definitions

Terms defined in the Facility Agreement shall, unless otherwise defined in this Deed, have the same meaning in this Deed. In addition, the following definitions apply in this Deed:

"Business Day" a day other than a Saturday, Sunday or public holiday in England when banks in London are open for business.

"Certificate of Title" any report on, or certificate of, title relating to the Property supplied to the Lender by the Mortgagor (or on its behalf).

"Charged Assets" all the assets, property and undertaking of the Mortgagor which are, or are expressed to be, subject to the Security created by, or pursuant to, this Deed (and references to the Charged Assets shall include references to any part of them).

"Collaboration Agreement" means an agreement entered into between the Mortgagor and/or the Borrower and the owners of any adjoining or neighbouring properties under which the parties agree to collaborate for the purposes of delivering the development of the Property and those other properties and which agreement may contain obligations relating to (inter alia) the provision and funding of roads services and other infrastructure and the compliance with any Planning Agreement. "Delegate" any person appointed by the Lender or any Receiver under clause 16 and any person appointed as attorney of the Lender, or any Receiver or Delegate.

"Disposal" means a sale, transfer or other disposal, but excluding a charge.

"Environment" the natural and man-made environment including all or any of the following media, namely air, water and land (including air within buildings and other natural or man-made structures above or below the ground) and any living organisms (including man) or systems supported by those media.

"Environmental Law" all applicable laws, statutes, regulations, secondary legislation, bye-laws, common law, directives, treaties and other measures, judgments and decisions of any court or tribunal, codes of practice and guidance notes in so far as they relate to or apply to the Environment.

"Environmental Licence" any authorisation, permit or licence necessary under Environmental Law in respect of any of the Charged Assets.

"Event of Default" has the meaning given to that expression in the Facility Agreement, and also includes:

- a. an Insolvency Event occuring in respect of the Mortgagor;
- b. the Mortgagor fails to comply with any provision of this Deed or the Facility Agreement where such failure would reasonably be expected to have a Material Adverse Effect and, if the default is capable of remedy, such default is not remedied within ten Business Days of the Lender notifying the Mortgagor of the default and the remedy required.

"Restated MN Facility Agreement" the facility agreement dated on or about the date of this Deed between (1) the Borrower (2) the Lender and (3) Jacqueline Anne Norgate for the provision of the loan facilities secured by this Deed.

"Finance Documents" has the meaning given to that expression in the Restated MN Facility Agreement.

"Group Company" means a company which is a member of the same group as the Borrower within the meaning of section 42 of the Landlord & Tenant Act 1954.

"Insolvency Event" means in relation to any person (whether an individual or a body corporate) (i) that person becomes insolvent or unable to pay its debts as they fall due or (ii) any steps are taken for or with a view to the making of an administration order or the appointment of an administrator or trustee in bankruptcy in respect of that person or any steps are taken for or with a view to the winding-up, dissolution, liquidation, reconstruction or reorganisation of that person or (iii) a bankruptcy petition is presented or (iv) that person enters into a voluntary arrangement or other dealing with any of its creditors with a view to avoiding, or in expectation of, insolvency or stopping or threatening to stop payments to creditors generally or (v) an encumbrancer takes possession or a trustee in bankruptcy (in the case of an individual) or a receiver or manager is appointed of the whole or any material part of that person's assets and includes any equivalent or analogous proceedings by whatever name known in whatever jurisdiction

"Insurance Policy" each contract and policy of insurance effected or maintained by the Mortgagor from time to time in respect of the Property.

"LPA 1925" the Law of Property Act 1925.

"Material Adverse Effect" means a material adverse effect on the value of the Lender's security created by this Deed.

"Planning Agreement" means any agreement required in connection with the development of the Property and other adjoining or neighbouring properties and required by the local planning authority or by any authority or body responsible for highways or Services which agreement may be under Section 106 of the Town & Country Planning Act 1990 (as amended) Section 111 Local Government Act 1972 Electricity Act 1989 Gas Act 1980 Highways Act 1980 Water Act 1989 Water Industry Act 1991 or any similar legislation and which includes a unilateral undertaking.

"Planning Applications" means the application for planning permission made to West Berkshire Council (reference 18/00828/OUTMAJ) validated on 11 April 2018 and any other application for planning permission for the development of all or part of the Property and other adjoining or neighbouring properties for primarily residential and associated and ancillary uses (such as schools, local shops and community uses) including, without limitation, any application to vary a planning permission or to discharge any planning condition and any planning permission (whether or not conditional) granted as a result of any such application.

"**Property**" the freehold property (whether registered or unregistered) owned by the Mortgagor described in Schedule 1.

"Receiver" a receiver or receiver and manager appointed by the Lender under clause 14.

"**Rental Income**" all amounts paid or payable to or for the account of the Mortgagor in connection with the letting, licence or grant of other rights of use or occupation of all or any part of the Property.

"Rights" any Security or other right or benefit whether arising by set-off, counterclaim, subrogation, indemnity, proof in liquidation or otherwise and whether from contribution or otherwise (but excluding rights attached to shares including rights to dividends paid out of distributable profits of the Borrower, salary, bonuses and other sums paid or payable to the Mortgagor or either of them or any person connected with them at any time prior to the enforcement of this Deed by the Lender).

"Secured Liabilities" all present and future obligations and liabilities of either the Borrower or the Mortgagor to the Lender, whether actual or contingent and whether owed jointly or severally, as principal or surety or in any other capacity, under or in connection with the Finance Documents (including, without limitation, those arising under clause 28.3.2), together with all interest (including, without limitation, default interest) accruing in respect of those obligations or liabilities.

"Security" any mortgage, charge (whether fixed or floating, legal or equitable), pledge, lien, assignment by way of security or other security interest securing any obligation of any person, or any other agreement or arrangement having a similar effect.

"Security Period" the period starting on the date of this Deed and ending on the date on which the Lender is satisfied that all the Secured Liabilities have been unconditionally and irrevocably paid and discharged in full and no further Secured Liabilities are capable of being outstanding.

"**Services**" means services for the supply of water, electricity, gas, television or telecommunication services or for the disposal of foul or surface water and any other relevant services.

"Valuation" any valuation relating to the Property supplied to the Lender by the Mortgagor (or on its behalf).

"VAT" value added tax or any equivalent tax chargeable in the UK or elsewhere.

1.2 Interpretation

In this Deed:

- 1.2.1 clause, Schedule and paragraph headings shall not affect the interpretation of this Deed;
- 1.2.2 a **person** includes an individual, firm, company, corporation, partnership, unincorporated body of persons, government, state or agency of a state or any association, trust, joint venture or consortium or other entity (whether or not having separate legal personality);
- 1.2.3 unless the context otherwise requires, words in the singular shall include the plural and in the plural shall include the singular;
- 1.2.4 unless the context otherwise requires, a reference to one gender shall include a reference to the other genders;
- 1.2.5 a reference to a party shall include that party's successors, permitted assigns and permitted transferees and this Deed shall be binding on, and enure to the benefit of, the parties to this Deed and their respective successors, permitted assigns and permitted transferees;
- 1.2.6 a reference to legislation or a legislative provision is a reference to it as amended, extended or re-enacted from time to time;
- 1.2.7 a reference to legislation or a legislative provision shall include all subordinate legislation made from time to time under that legislation or legislative provision;

- 1.2.8 a reference to writing or written includes fax but not email;
- 1.2.9 an obligation on a party not to do something includes an obligation not to allow that thing to be done;
- 1.2.10 a reference to **this Deed** (or any provision of it) or to any other agreement or document referred to in this Deed is a reference to this Deed, that provision or such other agreement or document as amended (in each case, other than in breach of the provisions of this Deed) from time to time;
- 1.2.11 unless the context otherwise requires, a reference to a clause or Schedule is to a clause of, or Schedule to, this Deed and a reference to a paragraph is to a paragraph of the relevant Schedule;
- 1.2.12 any words following the terms **including**, **include**, **in particular**, **for example** or any similar expression shall be interpreted as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms;
- 1.2.13 a reference to an **amendment** includes a novation, supplement or variation (and **amend** and **amended** shall be construed accordingly);
- 1.2.14 a reference to **assets** includes present and future properties, undertakings, revenues, rights and benefits of every description;
- 1.2.15 a reference to an **authorisation** includes an approval, authorisation, consent, exemption, filing, licence, notarisation, registration or resolution;
- 1.2.16 a reference to **continuing** in relation to an Event of Default means an Event of Default that has not been remedied or waived;
- 1.2.17 a reference to **determines** or **determined** means, unless the contrary is indicated, a determination made at the absolute discretion of the person making it; and
- 1.2.18 a reference to a **regulation** includes any regulation, rule, official directive, request or guideline (whether or not having the force of law) of any governmental, inter-governmental or supranational body, agency, department or regulatory, self-regulatory or other authority or organisation.

1.3 Clawback

If the Lender considers that an amount paid by the Borrower or the Mortgagor in respect of the Secured Liabilities is capable of being avoided or otherwise set aside on the liquidation or administration of the Borrower or the Mortgagor, or otherwise, then that amount shall not be considered to have been irrevocably paid for the purposes of this Deed.

1.4 Nature of security over real property

A reference in this Deed to a **charge or mortgage of or over the Property** includes:

- 1.4.1 all buildings and fixtures and fittings (including trade and tenant's fixtures and fittings) and fixed plant and machinery that are situated on or form part of the Property at any time;
- 1.4.2 the proceeds of the sale of any part of the Property and any other monies paid or payable in respect of or in connection with the Property;
- 1.4.3 the benefit of any covenants for title given, or entered into, by any predecessor in title of the Mortgagor in respect of the Property, and any monies paid or payable in respect of those covenants; and
- 1.4.4 all rights under any licence, agreement for sale or agreement for lease in respect of the Property.

1.5 Law of Property (Miscellaneous Provisions) Act 1989

For the purposes of section 2 of the Law of Property (Miscellaneous Provisions) Act 1989, the terms of the Finance Documents and of any side letters between any parties in relation to the Finance Documents are incorporated into this Deed.

1.6 Perpetuity period

If the rule against perpetuities applies to any trust created by this Deed, the perpetuity period shall be 125 years (as specified by section 5(1) of the Perpetuities and Accumulations Act 2009).

1.7 Schedules

The Schedules form part of this Deed and shall have effect as if set out in full in the body of this Deed. Any reference to this Deed includes the Schedules.

2 Covenant to pay

2.1 Covenant to pay

Subject to clause 2.2, the Mortgagor shall, on demand, pay to the Lender and discharge the Secured Liabilities when they become due.

2.2 Limited recourse

It is expressly agreed that the Mortgagor is not a guarantor of the Borrower in respect of all the Borrower's obligations to the Lender and, without affecting the right of the Lender to enforce this Deed, the Mortgagor is not liable to pay personally all amounts due or to become due to the Lender from the Borrower. Notwithstanding any other provision of this Deed or the other Finance Documents, it is expressly agreed that:

- 2.2.1 the sole recourse of the Lender to the Mortgagor under this Deed is to the Mortgagor's interest in the Charged Assets; and
- 2.2.2 the liability of the Mortgagor to the Lender pursuant to or otherwise in connection with this Deed or the other Finance Documents shall be:
 - 2.2.2.1 limited in aggregate to an amount equal to that recovered as a result of enforcement of this Deed with respect to the Charged Assets; and
 - 2.2.2.2 satisfied only from the proceeds of sale or other disposal or realisation of the Charged Assets pursuant to this Deed.

3 Grant of security

3.1 Legal mortgage and fixed charges

As a continuing security for the payment and discharge of the Secured Liabilities, the Mortgagor with full title guarantee charges to the Lender:

- 3.1.1 by way of a first legal mortgage, the Property; and
- 3.1.2 by way of a first fixed charge:
 - 3.1.2.1 all its rights in each Insurance Policy, including all claims, the proceeds of all claims and all returns of premiums in connection with each Insurance Policy, the Rental Income and the benefit of any guarantee or security in respect of the Rental Income to the extent not effectively assigned under clause 3.2;
 - 3.1.2.2 the benefit of all other contracts, guarantees, appointments and warranties relating to the Charged Assets and other documents to which the Mortgagor is a party or which are in its favour or of which it has the benefit relating to any letting, development, sale, purchase, use or the operation of the Charged Assets or otherwise relating to the Charged Assets (including, in each case, but without limitation, the right to demand and receive all monies whatever payable to or for its benefit under or arising from any of them, all remedies provided for in any of them or available at law or in equity in relation to any of them, the right to compel performance of any of them and all other rights, interests and benefits whatever accruing to or for its benefit arising from any of them); and
 - 3.1.2.3 all licences, consents and authorisations (statutory or otherwise) held or required in connection with the Mortgagor's business carried on at the Property or the use of any Charged Asset, and all rights in connection with them;

3.2 Assignment

As a continuing security for the payment and discharge of the Secured Liabilities, the Mortgagor with full title guarantee assigns to the Lender absolutely, subject to a proviso for reassignment on irrevocable discharge in full of the Secured Liabilities all its rights in each Insurance Policy, including all claims, the proceeds of all claims and all returns of premiums in connection with each Insurance Policy provided that nothing in this clause 3.2 shall constitute the Lender as mortgagee in possession.

4 Perfection of security

4.1 Registration of legal mortgage at the Land Registry

The Mortgagor consents to an application being made by the Lender to the Land Registrar for the following restriction in Form P to be registered against its title to the Property:

"No disposition of the registered estate by the proprietor of the registered estate, or by the proprietor of any registered charge, not being a charge registered before the entry of this restriction, is to be registered without a written consent signed by the proprietor for the time being of the charge dated 2024 in favour of Grundon Waste Management Limited referred to in the charges register or their conveyancer."

5 Further advances and Lender co-operation

The Lender covenants with the Mortgagor and the Borrower that it shall:

- 5.1 perform its obligations to make advances to the Borrower under the Restated MN Facility Agreement (including any obligation to make available further advances); and
- 5.2 PROVIDED THAT the Lender has received full payment of all amounts due to it at the relevant date and secured by this Deed, in order to facilitate the development of the Property by or on behalf of the Mortgagor or the Borrower:
 - 5.2.1 not unreasonably withhold the Lender's consent to any matter or thing connected with the Planning Applications; and
 - 5.2.2 if reasonably required so to do by the Mortgagor (at the Mortgagor' cost) and provided that such documents include a clause confirming that the Lender shall have no liability under such documents unless the Lender is in possession of the Property, and subject also to any amendments reasonably required by the Lender with reasonable promptness:
 - 5.2.2.1 sign and execute with the relevant local authority, statutory undertaker, drainage authority, Services company or other relevant third party such easements, wayleaves, licences rights and privileges or issue such related consents, in its capacity as chargeholder, as are reasonably necessary or desirable for the advantage and benefit of the Property and any part thereof;

- 5.2.2.2 issue the appropriate consent or DS3 or enter into such Planning Agreements, in its capacity as chargeholder, as are reasonably necessary for the development of the Property pursuant to the Planning Applications; and
- 5.2.2.3 enter into, or provide its consent to, such Collaboration Agreements, in its capacity as chargeholder, as are reasonably necessary for the development of the Property

5.3 Notices

If any notice (whether agreed or unilateral) is registered against the Mortgagor's title to the Property, the Mortgagor shall immediately provide the Lender with full particulars of the circumstances relating to such notice. If such notice was registered to protect a purported interest the creation of which is not permitted under this Deed, the Mortgagor shall immediately, and at its own expense, take such steps as the Lender may reasonably require to ensure that the notice is withdrawn or cancelled.

5.4 Cautions against first registration and notices

Whether or not title to the Property is registered at the Land Registry, if any caution against first registration or any notice (whether agreed or unilateral) is registered against the Mortgagor's title to the Property, the Mortgagor shall immediately provide the Lender with full particulars of the circumstances relating to such caution or notice. If such caution or notice was registered to protect a purported interest the creation of which is not permitted under this Deed, the Mortgagor shall immediately, and at its own expense, take such steps as the Lender may require to ensure that the caution or notice, as applicable, is withdrawn or cancelled.

6 Liability of the Mortgagor and Lender's protections

6.1 Liability not discharged

The Mortgagor's liability under this Deed in respect of any of the Secured Liabilities shall not be discharged, prejudiced or affected by:

- 6.1.1 any intermediate payment, settlement of account or discharge in whole or in part of the Secured Liabilities;
- 6.1.2 any variation, extension, discharge, compromise, dealing with, exchange or renewal of any right or remedy that the Lender may now or after the date of this Deed have from or against the Borrower, the Mortgagor or any other person in connection with the Secured Liabilities;
- 6.1.3 any act or omission by the Lender or any other person in taking up, perfecting or enforcing any Security, indemnity, or guarantee from or against the Borrower, the Mortgagor or any other person;
- 6.1.4 any termination, amendment, variation, novation, replacement or supplement of or to any of the Secured Liabilities including, without limitation, any change in the purpose of, any increase in or

extension of the Secured Liabilities and any addition of new Secured Liabilities;

- 6.1.5 any grant of time, indulgence, waiver or concession to the Borrower, the Mortgagor or any other person;
- 6.1.6 any insolvency, bankruptcy, liquidation, administration, winding-up, incapacity, limitation, disability, the discharge by operation of law, or any change in the constitution, name or style of the Borrower, the Mortgagor or any other person;
- 6.1.7 any invalidity, illegality, unenforceability, irregularity or frustration of any actual or purported obligation of, or Security held from, the Borrower, the Mortgagor or any other person in connection with the Secured Liabilities;
- 6.1.8 any claim or enforcement of payment from the Borrower, the Mortgagor or any other person; or
- 6.1.9 any other act or omission that would not have discharged or affected the liability of the Mortgagor had it been a principal debtor or by anything done or omitted by any person which, but for this provision, might operate to exonerate or discharge the Mortgagor or otherwise reduce or extinguish its liability under this Deed.

6.2 Immediate recourse

The Mortgagor waives any right it may have to require the Lender:

- 6.2.1 to take any action or obtain judgment in any court against the Borrower or any other person;
- 6.2.2 to make or file any claim in a bankruptcy, liquidation, administration or insolvency of the Borrower or any other person; or
- 6.2.3 to make demand, enforce or seek to enforce any claim, right or remedy against the Borrower or any other person,

before taking steps to enforce any of its rights or remedies under this Deed.

6.3 Non-competition

The Mortgagor warrants to the Lender that it has not taken or received, and shall not take, exercise or receive the benefit of any Rights from or against the Borrower, its liquidator, an administrator, co-guarantor or any other person in connection with any liability of, or payment by, the Mortgagor under this Deed but:

6.3.1 if any of the Rights is taken, exercised or received by the Mortgagor, those Rights and all monies at any time received or held in respect of those Rights shall be held by the Mortgagor on trust for the Lender for application in or towards the discharge of the Secured Liabilities under this Deed; and 6.3.2 on demand by the Lender, the Mortgagor shall promptly transfer, assign or pay to the Lender all Rights and all monies from time to time held on trust by the Mortgagor under this clause 6.3.

7 Representations and warranties

7.1 Times for making representations and warranties

The Mortgagor makes the representations and warranties set out in this clause 7 to the Lender on the date of this Deed and the representations and warranties contained in clause 6 are deemed to be repeated on each day of the Security Period with reference to the facts and circumstances existing at the time of repetition.

7.2 Non-contravention

The entry into and performance by the Mortgagor of, and the transactions contemplated by, this Deed do not and will not contravene or conflict with:

- 7.2.1 any agreement or instrument binding on it or its assets or constitute a default or termination event (however described) under any such agreement or instrument; or
- 7.2.2 any law or regulation or judicial or official order applicable to it.

7.3 Authorisations

The Mortgagor has obtained all required or desirable authorisations to enable it to enter into, exercise its rights and comply with its obligations in this Deed. Any such authorisations are in full force and effect.

7.4 Binding obligations

The Mortgagor's obligations under this Deed are legal, valid, binding and enforceable and this Deed creates:

- 7.4.1 valid, legally binding and enforceable Security for the obligations expressed to be secured by it; and
- 7.4.2 subject to (in the case of real property) registration at the Land Registry, perfected Security over the assets expressed to be subject to Security in it,

in favour of the Lender, having the priority and ranking expressed to be created by this Deed and ranking ahead of all (if any) Security and rights of third parties, except those preferred by law.

7.5 No litigation

No litigation, arbitration, administrative proceedings or investigations are taking place, pending or, to the Mortgagor's knowledge, threatened against it, or any of the Charged Assets.

7.6 Ownership of Charged Assets

The Mortgagor is the sole legal and beneficial owner of the Charged Assets and has good, valid and marketable title to the Property.

7.7 No Security

The Charged Assets are free from any Security other than the Security created by this Deed.

7.8 No adverse claims

The Mortgagor has not received, or acknowledged notice of, any adverse claim by any person in respect of the Charged Assets or any interest in them.

7.9 No adverse covenants

There are no covenants, agreements, reservations, conditions, interests, rights or other matters whatever that materially and adversely affect the Charged Assets.

7.10 No breach of laws

There is no breach of any law or regulation, that materially and adversely affects the Charged Assets.

7.11 No interference in enjoyment

No facility necessary for the enjoyment and use of the Charged Assets is subject to terms entitling any person to terminate or curtail its use.

7.12 No overriding interests

Nothing has arisen, has been created or is subsisting, that would be an overriding interest in the Property.

7.13 No breaches

The entry into of this Deed by the Mortgagor does not, and will not, constitute a breach of any policy, agreement, document, instrument or obligation binding on the Mortgagor or the Charged Assets.

7.14 Environmental compliance

The Mortgagor has, at all times, complied in all respects with all applicable Environmental Law and Environmental Licences.

7.15 Information for Valuations and Certificates of Title

- 7.15.1 All written information supplied by the Mortgagor or on its behalf for the purpose of each Valuation and Certificate of Title was true and accurate in all material respects at its date or at the date (if any) on which it was stated to be given.
- 7.15.2 The information referred to in clause 7.15.1 was, at its date or at the date (if any) on which it was stated to be given, complete and

the Mortgagor did not omit to supply any information that, if disclosed, would adversely affect the Valuation or Certificate of Title.

7.15.3 In the case of the first Valuation and Certificate of Title only, nothing has occurred since the date the information referred to in clause 7.15.1 was supplied and the date of this Deed that would adversely affect such Valuation or Certificate of Title.

7.16 Avoidance of security

No Security expressed to be created under this Deed is liable to be avoided, or otherwise set aside, on the liquidation or administration of the Mortgagor or otherwise.

8 General covenants

8.1 Negative pledge and disposal restrictions

The Mortgagor shall not at any time, except with the Lender's prior written consent:

- 8.1.1 create, purport to create or permit to subsist any Security on, or in relation to, any Charged Asset other than any Security created by this Deed;
- 8.1.2 sell, assign, transfer, part with possession of, or otherwise dispose of in any manner (or purport to do so), all or any part of, or any interest in, the Charged Assets; or
- 8.1.3 create or grant (or purport to create or grant) any interest in the Charged Assets in favour of a third party.

8.2 Preservation of Charged Assets

The Mortgagor shall not, without the prior consent of the Lender, do, or permit to be done, any act or thing that would or might depreciate, jeopardise or otherwise prejudice the security held by the Lender or materially diminish the value of any of the Charged Assets or the effectiveness of the security created by this Deed.

8.3 Compliance with laws and regulations

- 8.3.1 The Mortgagor shall not, without the Lender's prior written consent, use or permit the Charged Assets to be used in any way contrary to law.
- 8.3.2 The Mortgagor shall:
 - 8.3.2.1 comply with the requirements of any law or regulation relating to or affecting the Charged Assets or the use of them or any part of them;
 - 8.3.2.2 obtain, and promptly renew from time to time, and comply with the terms of all authorisations that are required in

connection with the Charged Assets or their use or that are necessary to preserve, maintain or renew any Charged Asset; and

- 8.3.2.3 promptly effect any maintenance, modifications, alterations or repairs that are required by any law or regulation to be effected on or in connection with the Charged Assets.
- 8.3.3 Notwithstanding the foregoing, the Mortgagor shall not be deemed in breach of their covenants under this Deed for minor breaches of law that have no Material Adverse Effect or that are remediable breaches which are remedied within a reasonable time after the Mortgagor become aware of the breach and the remedy required.

8.4 Enforcement of rights

The Mortgagor shall use its reasonable endeavours to:

- 8.4.1 procure the prompt observance and performance by the relevant counterparty to any agreement or arrangement with the Mortgagor and forming part of the Charged Assets of the covenants and other obligations imposed on such counterparty; and
- 8.4.2 enforce any rights and institute, continue or defend any proceedings relating to any of the Charged Assets that the Lender may require from time to time.

8.5 Notice of misrepresentation and breach

The Mortgagor shall, promptly on becoming aware of any of the same, notify the Lender in writing of:

- 8.5.1 any representation or warranty set out in this Deed that is incorrect or misleading in any material respect when made or deemed to be repeated; and
- 8.5.2 any breach of any covenant set out in this Deed.

8.6 Title documents

The Mortgagor shall, on the execution of this Deed, deposit with the Lender and the Lender shall, for the duration of this Deed, be entitled to hold:

- 8.6.1 all deeds and documents of title relating to the Charged Assets that are in the possession or control of the Mortgagor (and if these are not within the possession or control of the Mortgagor, the Mortgagor undertakes to obtain possession of all these deeds and documents of title); and
- 8.6.2 each Insurance Policy;

8.7 Notices to be given by the Mortgagor

- 8.7.1 The Mortgagor shall within five days of the execution of this Deed in respect of each Insurance Policy, give notice to the relevant insurer that it has assigned all its rights in that Insurance Policy (including all claims, the proceeds of all claims and all returns of premiums in connection with that Insurance Policy) under clause 0 and use reasonable endeavours to procure that each addressee of any such notice provides to the Lender promptly an acknowledgement of that notice;
- 8.7.2 The Mortgagor shall obtain the Lender's prior approval of the form of any notice or acknowledgement to be used under this clause 8.7.

8.8 Ranking of obligations

The Mortgagor's payment obligations under this Deed will, at all times, rank in all respects in priority to all its other indebtedness, other than indebtedness preferred by operation of law in the event of its bankruptcy.

8.9 Authorisations

The Mortgagor shall obtain all consents and authorisations necessary (and do all that is needed to maintain them in full force and effect) under any law or regulation of its jurisdiction of incorporation to enable it to perform its obligations under this Deed and to ensure the legality, validity, enforceability and admissibility in evidence of this Deed.

9 Property covenants

9.1 Repair and maintenance

The Mortgagor shall keep all premises, and fixtures and fittings on the Property, in good and substantial repair and condition and shall keep all premises adequately and properly painted and decorated and replace any fixtures and fittings that have become worn out or otherwise unfit for use with others of a like nature and equal value.

9.2 No alterations

- 9.2.1 The Mortgagor shall not, without the Lender's prior written consent:
 - 9.2.1.1 pull down or remove the whole or any part of any building forming part of the Property nor permit the same to occur; or
 - 9.2.1.2 make or permit to be made any alterations to the Property or sever or remove, or permit to be severed or removed, any of its fixtures or fittings (except to make any necessary repairs or renew or replace the same in accordance with clause 9.1).
- 9.2.2 The Mortgagor shall promptly give notice to the Lender if the premises or fixtures or fittings forming part of the Property are destroyed or damaged.

9.3 Insurance

- 9.3.1 The Mortgagor shall insure and keep insured the Charged Assets against:
 - 9.3.1.1 loss or damage by fire or terrorist acts, including any thirdparty liability arising from such acts;
 - 9.3.1.2 other risks, perils and contingencies that would be insured against by reasonably prudent persons carrying on the same class of business as the Mortgagor; and
 - 9.3.1.3 any other risk, perils and contingencies as the Lender may reasonably require.
- 9.3.2 Any such insurance must:
 - 9.3.2.1 be with an insurance company or underwriters, and on such terms, as are reasonably acceptable to the Lender;
 - 9.3.2.2 include property owners' public liability and third-party liability insurance; and
 - 9.3.2.3 be for not less than the replacement value of the relevant Charged Asset (meaning, in the case of any premises on the Property, the total cost of entirely rebuilding, reinstating or replacing the premises in the event of their being destroyed, together with architects', surveyors', engineers' and other professional fees and charges for shoring or propping up, demolition, site clearance and reinstatement with adequate allowance for inflation) and loss of rents payable by the tenants or other occupiers of the Property for a period of at least three years, including provision for increases in rent during the period of insurance.
- 9.3.3 The Mortgagor shall, if requested by the Lender, produce to the Lender each policy, certificate or cover note relating to any insurance required by clause 9.3.1.
- 9.3.4 The Mortgagor shall, if requested by the Lender, procure that a note of the Lender's interest is endorsed on each Insurance Policy (other than public liability and third-party liability insurances) effected or maintained by it or any person on its behalf in accordance with clause 9.3.1 but without the Lender having any liability for any premium in relation to those Insurance Policies unless it has expressly and specifically requested to be made liable in respect of any increase in premium or unpaid premium in respect of any Insurance Policy.
- 9.3.5 The Mortgagor shall ensure that each Insurance Policy effected or maintained by it or any person on its behalf in accordance with clause 9.3.1 contains:

- 9.3.5.1 a loss payee clause under which the Lender is named as first loss payee (other than in respect of any claim under any public liability and third-party liability insurances);
- 9.3.5.2 terms ensuring that it cannot be avoided or vitiated as against the Lender by reason of the act or default of any other insured party or any misrepresentation, nondisclosure or failure to make a fair presentation of risk by any other insured party;
- 9.3.5.3 a waiver of each insurer's rights of subrogation against the Mortgagor, the Lender and the tenants of the Property other than any such rights arising in connection with any fraud or criminal offence committed by any of those persons in respect of the Property or any Insurance Policy; and
- 9.3.5.4 terms ensuring that no insurer can repudiate, rescind or cancel it, treat it as avoided in whole or in part nor treat it as expired due to non-payment of premium without giving at least 30 days' prior written notice to the Lender.

9.4 Insurance premiums

The Mortgagor shall:

- 9.4.1 promptly pay all premiums in respect of each Insurance Policy required by clause 9.3.1 and do all other things necessary to keep that policy in full force and effect; and
- 9.4.2 (if the Lender so requires) give to the Lender copies of the receipts for all premiums and other payments necessary for effecting and keeping up each Insurance Policy required by clause 9.3.1.

9.5 No invalidation of insurance

The Mortgagor shall not do or omit to do, or permit to be done or omitted, any act or thing that may invalidate or otherwise prejudice any Insurance Policy required by clause 9.3.1.

9.6 Proceeds from Insurance Policies

All monies payable under any Insurance Policy required by clause 9.3.1 shall (whether or not the security constituted by this Deed has become enforceable):

- 9.6.1 be paid immediately to the Lender;
- 9.6.2 if they are not paid directly to the Lender by the insurers, be held, pending such payment, by the Mortgagor as trustee of the same for the benefit of the Lender; and
- 9.6.3 at the option of the Lender, be applied in making good or recouping expenditure in respect of the loss or damage for which those

monies are received or in, or towards, discharge or reduction of the Secured Liabilities.

9.7 Leases and licences affecting the Property

The Mortgagor shall not, without the Lender's prior written consent (not to be unreasonably withheld or delayed):

- 9.7.1 grant any licence or tenancy affecting the whole or any part of the Property, or exercise the statutory powers of leasing or of accepting surrenders under section 99 or section 100 of the LPA 1925 (or agree to grant any such licence or tenancy, or agree to exercise the statutory powers of leasing or of accepting surrenders under section 99 or section 100 of the LPA 1925);
- 9.7.2 in any other way dispose of, accept the surrender of, surrender or create any legal or equitable estate or interest in the whole or any part of the Property (or agree to dispose of, accept the surrender of, surrender or create any legal or equitable estate or interest in the whole or any part of the Property);
- 9.7.3 let any person into occupation, or share occupation, of the whole or any part of the Property; or
- 9.7.4 grant any consent or licence under any lease or licence affecting the Property.

9.8 No restrictive obligations

The Mortgagor shall not, without the Lender's prior written consent, enter into any onerous or restrictive obligations affecting the whole or any part of the Property or create or permit to arise any overriding interest, easement or right whatever in or over the whole or any part of the Property.

9.9 Proprietary rights

The Mortgagor shall procure that no person shall become entitled to assert any proprietary or other like right or interest over the whole or any part of the Property, without the Lender's prior written consent.

9.10 Compliance with and enforcement of covenants

The Mortgagor shall:

- 9.10.1 observe and perform all covenants, stipulations and conditions to which the Property, or the use of it, is or may be subject and (if the Lender so requires) produce to the Lender evidence sufficient to satisfy the Lender that those covenants, stipulations and conditions have been observed and performed; and
- 9.10.2 diligently enforce all covenants, stipulations and conditions benefiting the Property and shall not (and shall not agree to) waive, release or vary any of the same.

9.11 Notices or claims relating to the Property

- 9.11.1 The Mortgagor shall:
 - 9.11.1.1 give full particulars to the Lender of any notice, order, direction, designation, resolution, application, requirement or proposal given or made by any public or local body or authority (a **Notice**) that specifically applies to the Property, or to the locality in which it is situated, within seven days after becoming aware of the relevant Notice; and
 - 9.11.1.2 (if the Lender so requires) immediately, and at the cost of the Mortgagor, take all reasonable and necessary steps to comply with any Notice, and make, or join with the Lender in making, any objections or representations in respect of that Notice that the Lender thinks fit.
- 9.11.2 The Mortgagor shall give full particulars to the Lender of any claim, notice or other communication served on it in respect of any modification, suspension or revocation of any Environmental Licence or any alleged breach of any Environmental Law, in each case relating to the Property.

9.12 Payment of outgoings

The Mortgagor shall pay (or procure payment of the same) when due all charges, rates, taxes, duties, assessments and other outgoings relating to or imposed on the Property or on its occupier.

9.13 Rent reviews

The Mortgagor shall, if the Property is subject to occupational leases or licences, implement any upwards rent review provisions and shall not, without the Lender's prior written consent, agree to any change in rent to less than the open market rental value of the relevant part of the Property.

9.14 Environment

The Mortgagor shall in respect of the Property:

- 9.14.1 comply in all material respects with all the requirements of Environmental Law; and
- 9.14.2 obtain and comply in all material respects with all Environmental Licences.

9.15 Conduct of business on Property

The Mortgagor shall carry on its trade and business on those parts (if any) of the Property as are used for the purposes of trade or business in accordance with the standards of good management from time to time current in such trade or business.

9.16 Inspection

The Mortgagor shall permit the Lender, any Receiver and any person appointed by either of them to enter on and inspect the Property on reasonable prior notice.

9.17 VAT option to tax

The Mortgagor shall not, without the Lender's prior written consent:

- 9.17.1 exercise any VAT option to tax in relation to the Property; or
- 9.17.2 revoke any VAT option to tax exercised, and disclosed to the Lender in writing, before the date of this Deed.

10 Borrower covenants

- 10.1 The Borrower shall not without the prior written consent of the Lender and the Mortgagor seek to increase the amount (exclusive of accrued interest and any proper costs or charges) secured by the Prior Charge beyond the amount thereby secured as at the date of this Deed nor to allow any such increase to occur.
- 10.2 Neither the Borrower nor the Lender shall without the prior written consent of the Mortgagor seek to increase the amount (exclusive of accrued interest and any proper costs or charges) secured by this Deed beyond the amount secured by the Facility Agreement as at the date of this Deed nor allow any such increase to occur.

11 Powers of the Lender

11.1 Power to remedy

- 11.1.1 The Lender shall be entitled (but shall not be obliged) to remedy, at any time, a breach by the Mortgagor of any of its obligations contained in this Deed.
- 11.1.2 The Mortgagor irrevocably authorises the Lender and its agents to do all things that are necessary or desirable for that purpose.
- 11.1.3 The Mortgagor shall reimburse the Lender, on a full indemnity basis, for any monies the Lender expends in remedying a breach by the Mortgagor of its obligations contained in this Deed and such monies shall carry interest in accordance with clause 18.1.
- 11.1.4 In remedying any breach in accordance with this clause 11.1, the Lender, its agents and their respective officers, agents and employees shall be entitled to enter onto the Property and to take any action as the Lender may reasonably consider necessary or desirable including, without limitation, carrying out any repairs, other works or development.

11.2 Exercise of rights

The rights of the Lender under clause 11.1 are without prejudice to any other rights of the Lender under this Deed. The exercise of any rights of the Lender under this Deed shall not make the Lender liable to account as a mortgagee in possession.

11.3 Lender has Receiver's powers

To the extent permitted by law, any right, power or discretion conferred by this Deed (either expressly or impliedly) or by law on a Receiver may, after the security constituted by this Deed has become enforceable, be exercised by the Lender in relation to any of the Charged Assets whether or not it has taken possession of any Charged Asset and without first appointing a Receiver or notwithstanding the appointment of a Receiver.

11.4 Indulgence

The Lender may, at its discretion, grant time or other indulgence, or make any other arrangement, variation or release with any person not being a party to this Deed (whether or not any such person is jointly liable with the Mortgagor) in respect of any of the Secured Liabilities or of any other security for them without prejudice either to this Deed or to the liability of the Mortgagor for the Secured Liabilities.

12 When security becomes enforceable

12.1 Security becomes enforceable on Event of Default

The security constituted by this Deed shall become immediately enforceable if an Event of Default occurs.

12.2 Discretion

After the security constituted by this Deed has become enforceable, the Lender may, in its absolute discretion, enforce all or any part of that security at the times, in the manner and on the terms it thinks fit, and take possession of and hold or dispose of all or any part of the Charged Assets.

13 Enforcement of security

13.1 Enforcement powers

- 13.1.1 For the purposes of all powers implied by statute, the Secured Liabilities are deemed to have become due and payable on the date of this Deed.
- 13.1.2 The power of sale and other powers conferred by section 101 of the LPA 1925 (as varied or extended by this Deed) shall be immediately exercisable at any time after the security constituted by this Deed has become enforceable under clause 12.1.
- 13.1.3 Section 103 of the LPA 1925 does not apply to the security constituted by this Deed.

13.2 Extension of statutory powers of leasing

The statutory powers of leasing and accepting surrenders conferred on mortgagees under the LPA 1925 and by any other statute are extended so as to authorise the Lender and any Receiver, at any time after the security constituted by this Deed has become enforceable, whether in its own name or in that of the Mortgagor, to:

- 13.2.1 grant a lease or agreement for lease;
- 13.2.2 accept surrenders of leases; or
- 13.2.3 grant any option in respect of the whole or any part of the Property with whatever rights relating to other parts of it,

whether or not at a premium and containing such covenants on the part of the Mortgagor, and on such terms and conditions (including the payment of money to a lessee or tenant on a surrender), as the Lender or Receiver thinks fit, without the need to comply with any of the restrictions imposed by sections 99 and 100 of the LPA 1925.

13.3 Redemption of prior Security

- 13.3.1 At any time after the security constituted by this Deed has become enforceable, the Lender may:
 - 13.3.1.1 redeem any prior Security over any Charged Asset;
 - 13.3.1.2 procure the transfer of that Security to itself; and
 - 13.3.1.3 settle and pass the accounts of the holder of any prior Security (and any accounts so settled and passed shall, in the absence of any manifest error, be conclusive and binding on the Mortgagor).
- 13.3.2 The Mortgagor shall pay to the Lender immediately on demand all principal, interest, costs, charges and expenses of, and incidental to, any such redemption or transfer, and such amounts shall be secured by this Deed as part of the Secured Liabilities.

13.4 Protection of third parties

No purchaser, mortgagee or other person dealing with the Lender, any Receiver or any Delegate shall be concerned to enquire:

- 13.4.1 whether any of the Secured Liabilities have become due or payable, or remain unpaid or undischarged;
- 13.4.2 whether any power the Lender, a Receiver or Delegate is purporting to exercise has become exercisable or is being properly exercised; or
- 13.4.3 how any money paid to the Lender, any Receiver or any Delegate is to be applied.

13.5 Privileges

Each Receiver and the Lender is entitled to all the rights, powers, privileges and immunities conferred by the LPA 1925 on mortgagees and receivers.

13.6 Exclusion of liability

Neither the Lender, nor any Receiver or Delegate, shall be liable to the Mortgagor or any other person:

- 13.6.1 (by reason of entering into possession of a Charged Asset, or for any other reason) to account as mortgagee in possession in respect of all or any of the Charged Assets;
- 13.6.2 for any loss on realisation, or for any act, default or omission for which a mortgagee in possession might be liable; or
- 13.6.3 for any expense, loss or liability:
 - 13.6.3.1 relating to the enforcement of, or any failure to enforce or delay in enforcing, any security constituted by or pursuant to this Deed;
 - 13.6.3.2 relating to an exercise of rights, or by any failure to exercise or delay in exercising, rights under this Deed; or
 - 13.6.3.3 arising in any other way in connection with this Deed,

except that this does not exempt the Lender or any Receiver or Delegate from liability for losses caused by the gross negligence, fraud or wilful misconduct of the Lender or the relevant Receiver or Delegate.

13.7 Relinquishing possession

If the Lender, any Receiver or Delegate enters into or takes possession of a Charged Asset, it or they may at any time relinquish possession.

13.8 Conclusive discharge to purchasers

The receipt of the Lender, or any Receiver or Delegate, shall be a conclusive discharge to a purchaser and, in making any sale or other disposal of any of the Charged Assets or in making any acquisition in the exercise of their respective powers, the Lender, and every Receiver and Delegate may do so for any consideration, in any manner and on any terms that it or they think fit.

14 Receivers

14.1 Appointment

At any time after the security constituted by this Deed has become enforceable, or at the request of the Mortgagor, the Lender may, without further notice, appoint by way of deed, or otherwise in writing, any one or more persons to be a Receiver of all or any part of the Charged Assets.

14.2 Removal

The Lender may, without further notice, from time to time, by way of deed, or otherwise in writing, remove any Receiver appointed by it and may, whenever it thinks fit, appoint a new Receiver in the place of any Receiver whose appointment may for any reason have terminated.

14.3 Remuneration

The Lender may fix the remuneration of any Receiver appointed by it without the restrictions contained in section 109 of the LPA 1925 and the remuneration of the Receiver shall be a debt secured by this Deed, to the extent not otherwise discharged.

14.4 **Power of appointment additional to statutory powers**

The power to appoint a Receiver conferred by this Deed shall be in addition to all statutory and other powers of the Lender under the Insolvency Act 1986, the LPA 1925 or otherwise, and shall be exercisable without the restrictions contained in sections 103 and 109 of the LPA 1925 or otherwise.

14.5 Power of appointment exercisable despite prior appointments

The power to appoint a Receiver (whether conferred by this Deed or by statute) shall be, and remain, exercisable by the Lender despite any prior appointment in respect of all or any part of the Charged Assets.

14.6 Agent of the Mortgagor

Any Receiver appointed by the Lender under this Deed shall be the agent of the Mortgagor and the Mortgagor shall be solely responsible for the contracts, engagements, acts, omissions, defaults, losses and remuneration of that Receiver and for liabilities incurred by that Receiver. The agency of each Receiver shall continue until the Mortgagor goes into liquidation and after that the Receiver shall act as principal and shall not become the agent of the Lender.

15 Powers of Receiver

15.1 Powers additional to statutory powers

- 15.1.1 Any Receiver appointed by the Lender under this Deed shall, in addition to the rights, powers and discretions conferred on them by statute, have the rights, powers and discretions set out in clause 15.2 to clause 15.19.
- 15.1.2 A Receiver has all the rights, powers and discretions conferred on a receiver (or a receiver and manager) under the LPA 1925, and shall have those rights, powers and discretions conferred on an administrative receiver under the Insolvency Act 1986 whether they are an administrative receiver or not.
- 15.1.3 If there is more than one Receiver holding office at the same time, each Receiver may (unless the document appointing them states

otherwise) exercise all of the powers conferred on a Receiver under this Deed individually and to the exclusion of any other Receiver.

15.1.4 Any exercise by a Receiver of any of the powers given by clause 15 may be on behalf of the Mortgagor, the directors of the Mortgagor or themself.

15.2 Repair and develop the Property

A Receiver may undertake or complete any works of repair, alteration, building or development on the Property and may apply for and maintain any planning permission, development consent, building regulation approval or any other permission, consent or licence to carry out any of the same.

15.3 Grant or accept surrenders of leases

A Receiver may grant, or accept, surrenders of any leases or tenancies affecting the Property on any terms, and subject to any conditions, that they think fit.

15.4 Employ personnel and advisers

- 15.4.1 A Receiver may provide services and employ, or engage, any managers, officers, servants, contractors, workmen, agents, other personnel and professional advisers on any terms, and subject to any conditions, that they think fit.
- 15.4.2 A Receiver may discharge any such person or any such person appointed by the Mortgagor.

15.5 Make and revoke VAT options to tax

A Receiver may make, exercise or revoke any VAT option to tax as they think fit.

15.6 Charge for remuneration

A Receiver may charge and receive any sum by way of remuneration (in addition to all costs, charges and expenses incurred by them) that the Lender may prescribe or agree with them.

15.7 Take possession

A Receiver may take immediate possession of, get in and realise any Charged Asset.

15.8 Manage or reconstruct the Mortgagor's business

A Receiver may carry on, manage, develop, reconstruct, amalgamate or diversify or concur in carrying on, managing, developing, reconstructing, amalgamating or diversifying the business of the Mortgagor carried out at the Property.

15.9 Dispose of Charged Assets

A Receiver may grant options and licences over all or any part of the Charged Assets, grant any other interest or right over, sell, exchange, assign or lease (or concur in granting options and licences over all or any part of the Charged Assets, granting any other interest or right over, selling, exchanging, assigning or leasing) all or any of the Charged Assets in respect of which they are appointed for such consideration and in such manner (including, without limitation, by public auction or private sale) and generally on any terms and conditions as they think fit. A Receiver may promote, or concur in promoting, a company to purchase the Charged Assets to be disposed of by them.

15.10 Sever fixtures and fittings

A Receiver may sever and sell separately any fixtures or fittings from the Property without the consent of the Mortgagor.

15.11 Give valid receipts

A Receiver may give a valid receipt for all monies and execute all assurances and things that may be proper or desirable for realising any of the Charged Assets.

15.12 Make settlements

A Receiver may settle, adjust, refer to arbitration, compromise and arrange any claim, account, dispute, question or demand with or by any person who claims to be a creditor of the Mortgagor or relating in any way to any Charged Asset.

15.13 Bring legal action

A Receiver may bring, prosecute, enforce, defend and abandon all actions, suits and proceedings in relation to any of the Charged Assets as they think fit.

15.14 Insure

A Receiver may, if they think fit, but without prejudice to the indemnity in clause 18.2, effect with any insurer any policy of insurance either in lieu or satisfaction of, or in addition to, the insurance required to be maintained by the Mortgagor under this Deed.

15.15 Borrow

A Receiver may, for whatever purpose they think fit, raise and borrow money either unsecured or on the security of all or any of the Charged Assets in respect of which they are appointed on any terms that they think fit (including, if the Lender consents, terms under which that security ranks in priority to this Deed).

15.16 Redeem prior Security

A Receiver may redeem any prior Security and settle and pass the accounts to which the Security relates. Any accounts so settled and passed shall be, in the absence of any manifest error, conclusive and binding on the Mortgagor, and the monies so paid shall be deemed to be an expense properly incurred by the Receiver.

15.17 Delegation

A Receiver may delegate their powers in accordance with this Deed.

15.18 Absolute beneficial owner

A Receiver may, in relation to any of the Charged Assets, exercise all powers, authorisations and rights they would be capable of exercising as, and do all those acts and things, an absolute beneficial owner could exercise or do in the ownership and management of all or any part of the Charged Assets.

15.19 Incidental powers

A Receiver may do any other acts and things that they:

- 15.19.1 may consider desirable or necessary for realising any of the Charged Assets;
- 15.19.2 may consider incidental or conducive to any of the rights or powers conferred on a Receiver under or by virtue of this Deed or law; or
- 15.19.3 lawfully may or can do as agent for the Mortgagor.

16 Delegation

16.1 Delegation

The Lender or any Receiver may delegate (either generally or specifically) by power of attorney or in any other manner to any person any right, power, authority or discretion conferred on it or them by this Deed (including the power of attorney granted under clause 20.1).

16.2 Terms

The Lender and each Receiver may make a delegation on the terms and conditions (including the power to sub-delegate) that it or they think fit.

16.3 Liability

Neither the Lender nor any Receiver shall be in any way liable or responsible to the Mortgagor for any loss or liability of any nature arising from any act, default, omission or misconduct on the part of any Delegate.

17 Application of proceeds

17.1 Order of application of proceeds

All monies received or recovered by the Lender, a Receiver or a Delegate under this Deed or in connection with the realisation or enforcement of all or part of the security constituted by this Deed (other than sums received under any Insurance Policy), shall (subject to the claims of any person having prior rights and by way of variation of the LPA 1925) be applied in the following order of priority (but without prejudice to the Lender's right to recover any shortfall from the Mortgagor or the Borrower:

- 17.1.1 in or towards payment of all costs, liabilities, charges and expenses incurred by or on behalf of the Lender (and any Receiver, Delegate, attorney or agent appointed by it) under or in connection with this Deed and of all remuneration due to any Receiver under or in connection with this Deed;
- 17.1.2 in or towards payment of the Secured Liabilities in any order and manner that the Lender determines; and
- 17.1.3 in payment of the surplus (if any) to the Mortgagor or other person entitled to it.

17.2 Appropriation

Neither the Lender, any Receiver nor any Delegate shall be bound (whether by virtue of section 109(8) of the LPA 1925, which is varied accordingly, or otherwise) to pay or appropriate any receipt or payment first towards interest rather than principal or otherwise in any particular order between any of the Secured Liabilities.

17.3 Suspense account

All monies received by the Lender, a Receiver or a Delegate under this Deed (other than sums received under any Insurance Policy that are not going to be applied in or towards discharge of the Secured Liabilities):

- 17.3.1 may, at the discretion of the Lender, Receiver or Delegate, be credited to a suspense account;
- 17.3.2 shall bear interest, if any, at the rate agreed in writing between the Lender and the Mortgagor; and
- 17.3.3 may be held in that account for so long as the Lender, Receiver or Delegate thinks fit.

18 Costs and indemnity

18.1 Costs

The Mortgagor shall, promptly on demand, pay to, or reimburse, the Lender and any Receiver, on a full indemnity basis, all fees, costs, charges, losses, liabilities and expenses (including, without limitation, legal and other professional fees and printing and out-of-pocket expenses) and any taxes thereon incurred by the Lender, any Receiver or any Delegate in connection with:

- 18.1.1 the negotiation, preparation, printing, execution and delivery of this Deed and any other documents referred to in this Deed;
- 18.1.2 the Charged Assets;
- 18.1.3 taking, holding, protecting, perfecting, preserving or enforcing (or attempting to do so) any of the security constituted by this Deed or any rights of the Lender, a Receiver or a Delegate under this Deed;
- 18.1.4 any amendment, extension, waiver, consent or suspension of rights (or any proposal for any of these) under or in connection with this Deed;
- 18.1.5 any release of any security constituted by this Deed;
- 18.1.6 taking proceedings for, or recovering, any of the Secured Liabilities; or
- 18.1.7 any actual or alleged breach by any person of any law or regulation (including the investigation of that breach),

together with interest, which shall accrue and be payable (without the need for any demand for payment being made) from the date on which the relevant fee, cost, charge, loss, liability, expense or tax arose until its full discharge (whether before or after judgment) at the rate and in the manner specified in the Facility Agreement.

18.2 Indemnity

- 18.2.1 The Mortgagor shall, promptly on demand, indemnify the Lender, each Receiver and each Delegate, and their respective employees and agents against any failure or delay in paying the fees, costs, charges, losses, liabilities, expenses, taxes or interest referred to in clause 18.1 above.
- 18.2.2 Any past or present employee or agent may enforce the terms of this clause 18.2 subject to and in accordance with the provisions of the Contracts (Rights of Third Parties) Act 1999.

19 Further assurance

19.1 Further assurance

The Mortgagor shall promptly, at its own expense, take whatever action the Lender or any Receiver may reasonably require for:

- 19.1.1 creating, perfecting or protecting the security intended to be created by this Deed;
- 19.1.2 facilitating the realisation of any Charged Asset; or

19.1.3 facilitating the exercise of any right, power, authority or discretion exercisable by the Lender or any Receiver in respect of any Charged Asset,

including, without limitation the execution of any mortgage, transfer, conveyance, assignment or assurance of all or any of the assets forming part of (or intended to form part of) the Charged Assets (whether to the Lender or to its nominee) and the giving of any notice, order or direction and the making of any filing or registration which, in any such case, the Lender may consider necessary or desirable.

20 Power of attorney

20.1 Appointment of attorneys

By way of security, the Mortgagor irrevocably appoints the Lender, every Receiver and every Delegate separately to be the attorney of the Mortgagor and, in its name, on its behalf and as its act and deed, to execute any documents and do any acts and things that:

- 20.1.1 the Mortgagor is required to execute and do under this Deed; or
- 20.1.2 any attorney deems proper or desirable in exercising any of the rights, powers, authorities and discretions conferred by this Deed or by law on the Lender, any Receiver or any Delegate.

20.2 Ratification of acts of attorneys

The Mortgagor ratifies and confirms, and agrees to ratify and confirm, anything that any of its attorneys may do in the proper and lawful exercise, or purported exercise, of all or any of the rights, powers, authorities and discretions referred to in clause 20.1.

21 Release

21.1 Release

Subject to clause 28.3, at the end of the Security Period, the Lender shall, at the request and cost of the Mortgagor, take whatever action is necessary to:

- 21.1.1 release the Charged Assets from the security constituted by this Deed; and
- 21.1.2 reassign the Charged Assets to the Mortgagor.

22 Assignment and transfer

22.1 Assignment by Lender

- 22.1.1 At any time, without the consent of the Mortgagor, the Lender may assign any of its rights or transfer any of its rights and obligations under this Deed.
- 22.1.2 The Lender may disclose to any actual or proposed assignee or transferee any information in its possession that relates to the

Mortgagor, the Charged Assets and this Deed that the Lender considers appropriate, provided that before any such disclosure, the recipient shall have signed a confidentiality agreement in a form reasonably acceptable to the Mortgagor.

22.2 Assignment by Mortgagor

The Mortgagor may not assign any of its rights, or transfer any of its rights or obligations, under this Deed or enter into any transaction which would result in any of those rights or obligations passing to another person.

23 Set-off

23.1 Lender's right of set-off

The Lender may at any time set off any liability of the Mortgagor to the Lender against any liability of the Lender to the Mortgagor, whether either liability is present or future, liquidated or unliquidated, and whether or not either liability arises under this Deed. If the liabilities to be set off are expressed in different currencies, the Lender may convert either liability at a market rate of exchange for the purpose of set-off. Any exercise by the Lender of its rights under this clause 23.1 shall not limit or affect any other rights or remedies available to it under this Deed or otherwise.

23.2 No obligation to set off

The Lender is not obliged to exercise its rights under clause 23.1. If it does exercise those rights it must promptly notify the Mortgagor of the set-off that has been made.

23.3 Exclusion of Mortgagor's right of set-off

All payments made by the Mortgagor to the Lender under this Deed shall be made in full without any set-off, counterclaim, deduction or withholding (other than any deduction or withholding of tax as required by law).]

24 Amendments, waivers and consents

24.1 Amendments

No amendment of this Deed shall be effective unless it is in writing and signed by, or on behalf of, each party (or its authorised representative).

24.2 Waivers and consents

- 24.2.1 A waiver of any right or remedy under this Deed or by law, or any consent given under this Deed, is only effective if given in writing by the waiving or consenting party and shall not be deemed a waiver of any subsequent right or remedy. It only applies to the circumstances in relation to which it is given and shall not prevent the party giving it from subsequently relying on the relevant provision.
- 24.2.2 A failure by the Lender to exercise, or delay by it in exercising any right or remedy provided under this Deed or by law shall not

constitute a waiver of that or any other right or remedy, prevent or restrict any further exercise of that or any other right or remedy or constitute an election to affirm this Deed. No single or partial exercise of any right or remedy provided under this Deed or by law shall prevent or restrict the further exercise of that or any other right or remedy. No election to affirm this Deed by the Lender shall be effective unless it is in writing.

24.3 Rights and remedies

The rights and remedies provided under this Deed are cumulative and are in addition to, and not exclusive of, any rights and remedies provided by law.

25 Partial invalidity

If, at any time, any provision of this Deed is or becomes invalid, illegal or unenforceable in any respect under any law of any jurisdiction, neither the legality, validity or enforceability of the remaining provisions nor the legality, validity or enforceability of such provision under the law of any other jurisdiction will in any way be affected or impaired.

26 Counterparts

26.1 Counterparts

- 26.1.1 This Deed may be executed in any number of counterparts, each of which when executed and delivered shall constitute a duplicate original, but all the counterparts shall together constitute one deed.
- 26.1.2 No counterpart shall be effective until each party has executed and delivered at least one counterpart.

27 Third party rights

27.1 Third party rights

- 27.1.1 Except as expressly provided elsewhere in this Deed, a person who is not a party to this Deed has no right under the Contracts (Rights of Third Parties) Act 1999 to enforce, or enjoy the benefit of, any term of this Deed.
- 27.1.2 Notwithstanding any term of this Deed, the consent of any person who is not a party to this Deed is not required to rescind or vary this Deed at any time.

28 Further provisions

28.1 Independent security

The security constituted by this Deed shall be in addition to, and independent of, any other security or guarantee that the Lender may hold for any of the Secured Liabilities at any time. No prior security held by the Lender over the whole or any part of the Charged Assets shall merge in the security created by this Deed.

28.2 Continuing security

The security constituted by this Deed shall remain in full force and effect as a continuing security for the Secured Liabilities, despite any settlement of account, or intermediate payment, or other matter or thing, unless and until the Lender discharges this Deed in writing.

28.3 Discharge conditional

Any release, discharge or settlement between the Mortgagor and the Lender shall be conditional on no payment or security received by the Lender in respect of the Secured Liabilities being avoided, reduced, set aside or ordered to be refunded under any law relating to insolvency, bankruptcy, winding-up, administration, receivership or for any other reason. Despite any such release, discharge or settlement:

- 28.3.1 the Lender or its nominee may retain this Deed and the security created by or under it, including all certificates and documents relating to the whole or any part of the Charged Assets, for any period that the Lender deems necessary to provide the Lender with security against any such avoidance, reduction or order for refund; and
- 28.3.2 the Lender may recover the value or amount of such security or payment from the Mortgagor subsequently as if the release, discharge or settlement had not occurred.

28.4 Certificates

Any certification or determination by the Lender of any rate or amount under this Deed is, in the absence of manifest error, conclusive evidence of the matters to which it relates.

28.5 Consolidation

The restriction on the right of consolidation contained in section 93 of the LPA 1925 shall not apply to this Deed.

29 Notices

29.1 Delivery

Any notice or other communication given to a party under or in connection with this Deed shall be:

- 29.1.1 in writing;
- 29.1.2 delivered by hand, by pre-paid first-class post or other next working day delivery service; and
- 29.1.3 sent to:
 - 29.1.3.1 the Mortgagor at:

29.2 Receipt by Mortgagor

Any notice or other communication that the Lender gives to the Mortgagor shall be deemed to have been received:

- 29.2.1 if delivered by hand, at the time it is left at the relevant address; and
- 29.2.2 if posted by pre-paid first-class post or other next working day delivery service, on the second Business Day after posting.

A notice or other communication given as described in clause 29.2.1 on a day that is not a Business Day, or after normal business hours, in the place it is received, shall be deemed to have been received on the next Business Day.

29.3 Receipt by Lender

Any notice or other communication given to the Lender shall be deemed to have been received only on actual receipt.

29.4 Service of proceedings

This clause 29 does not apply to the service of any proceedings or other documents in any legal action or, where applicable, any arbitration or other method of dispute resolution.

29.5 No notice or communication by email

A notice or other communication given under or in connection with this Deed is not valid if sent by email.

30 Governing law and jurisdiction

30.1 Governing law

This Deed and any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales.

30.2 Jurisdiction

Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction over any dispute or claim (including noncontractual disputes or claims) arising out of or in connection with this Deed or its subject matter or formation.

30.3 Other service

The Mortgagor irrevocably consents to any process in any legal action or proceedings under clause 30.2 being served on it in accordance with the provisions of this Deed relating to service of notices. Nothing contained in this Deed shall affect the right to serve process in any other manner permitted by law.
