
- **ORDINARY RESOLUTIONS:**

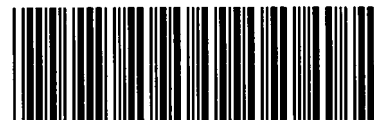
