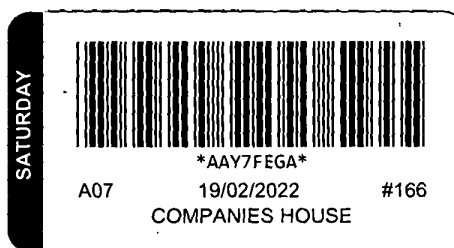



The mortgage is secured by a legal charge dated 15 May 2015. The security relates to 0.564 acres of freehold land at forest gate business park, Christchurch road Ringwood.
