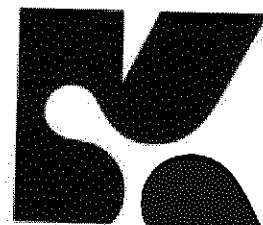



4. You apply to the Land Registry for the following restriction to be registered in the Proprietorship Register of the title to the property:
