IT IS ORDERED THAT

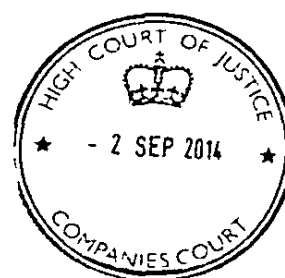
- 1 The Applicant be removed as joint liquidator of the Company and Mr Bowles be appointed in substitution for the Applicant as joint liquidator of the Company with Stephen M Katz

- 2 The Applicant be discharged from his undertaking given to the Court on 26 April 2012 and recorded in the Order of that date
- 3 Mr Bowles shall have the same powers, authorities and entitlements as the Applicant under the Order of 26 April 2012 and, for the avoidance of doubt, shall hold office on the same terms otherwise as to fees and authority
- 4 As soon as reasonably practicable, and in any event within 28 days of the date of this Order the Applicant shall procure that notice be given to the Company's creditors of his removal from the liquidation of the Company and the appointment of Mr Bowles in his place The said notice shall make express reference to the permission to apply at paragraph 7 below
- 5 The Applicant shall be granted his release 28 days after notice is given under paragraph 4 above without being required to apply to the Secretary of State
- 6 The Applicant, Mr Bowles and Mr Katz be authorised to dispense with any requirement to file receipts and payments accounts as a consequence of the removal and replacement of the Applicant as joint liquidator of the Company and Mr Bowles and Mr Katz shall file receipts and payments accounts on the normal way
- 7 Permission to any creditor to apply to vary or discharge this Order within 21 days of receipt of the notices directed to be sent under paragraph 4 above.
- 8 The costs of this application (including the VAT) be paid by Carter Backer Winter of Enterprise House, 21 Buckle Street, Aldgate East, London E1 8NN (save that nothing shall prejudice the charging to the estate of the cost of obtaining an Insolvency Practitioner's licence bond in respect of the estate)
