

Single Debenture

The charge created by the Debenture is as regards the premises First Secondly and Thirdly described a fixed first charge (and as regards all those parts of the premises First and Secondly described now vested in the Company constitutes a charge by way of legal mortgage thereon) and as to the premises Fourthly described is a floating charge but so that the Company may not without the consent in writing of the Bank create any mortgage debenture or charge upon and so that no lien may in any case or in any manner arise on or affect any part of the premises Fourthly described ranking either in priority to or pari passu with the charge thereby created.
