- (1) THINCATS LOAN SYNDICATES LIMITED (registered in England and Wales with company number 07341131) whose registered office is situate at The Opvecoto, Pimilico Farm, Austroy Lanc, No Mans Heath, Tamworth, Staffordshire 879 0PF acting as security trustee for the Syndicate Members (the "Security" Trustee"); and
- (2) STADDON HOUSE LIMITED (registered in England and Wales with company number 12814964 whose registered office is situate at Orbital House, 20 Eastern Road, Roreford, Essex, RM1 3PJ (the "Company").

#### BACKGROUND

- (A) This Debenture provides security which the Company has agreed to give the Security Trustee for all of the Company's obligations to the Syndrcate Members.

### 4. CHARGING CLAUSE

### 5. NATURE OF CHARGES

#### 14. SALE
