Notes to the Financial Statements

For the year ended 28 February 2014

1. Accounting Policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

1.2 Going concern

The accounts have been prepared on a going concern basis. The directors have prepared forecasts and reviewed capital requirements for twelve months from the date of approving these financial statements, which indicate the business will continue to trade for at least twelve months.

1.3 Turnover

Turnover comprises of guaranteed income receivable from the agreements to supply energy during the period. Any uninvoiced income is accrued in the period in which it has been generated.

1.4 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less depreciation. Depreciation is provided at rates calculated to write off the cost of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Other fixed assets represents the costs of construction of ground source heat plants: ground source heat pumps, planning and professional fees capitalised and depreciated at 4% per annum on a straight line basis.

1.5 Deferred taxation

Deferred tax is recognised on all timing differences where the transactions or events that give the company an obligation to pay more tax in the future, or a right to pay less tax in the future, have occurred by the Balance Sheet date. Deferred tax assets are recognised when it is more likely than not that they will be recovered. Deferred tax is measured using rates of tax that have been enacted or substantively enacted by the Balance sheet date.

1. Accounting Policies (continued)

1.6 Financial instruments

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the entity after deducting all of its financial liabilities.

Where the contractual obligations of financial instruments (including share capital) are equivalent to a similar debt instrument, those financial instruments are classed as financial liabilities. Financial liabilities are presented as such in the Balance Sheet. Finance costs and gains or losses relating to financial liabilities are included in the Profit and loss account. Finance costs are calculated so as to produce a constant rate of return on the outstanding liability.

Where the contractual terms of share capital do not have any terms meeting the definition of a financial liability then this is classed as an equity instrument. Dividends and distributions relating to equity instruments are debited direct to equity.

Interest of £87,080 (2013 - £65,310) has been charged on these loans during the year. There were no arrangement fees charged by Octopus VCT Plc to the company during the year (2013 - £10,000). The total amount outstanding and included in other loans at 28 February 2014 was £700,000 (2013 - £700,000).

In the prior year, the company received loans totalling £700,000 from Octopus VCT 2 Plc a shareholder of Superior Heat Limited. Interest of £87,080 (2013 - £65,310) has been charged on these loans during the year. There were no arrangement fees charged by Octopus VCT 2 Plc to the company during the year (2013 - £50,000). The total amount outstanding and included in other loans at 28 February 2014 was £700,000 (2013 - £700,000).

Octopus Investments Limited, a related party due to its significant influence over the company, charged monitoring fees totalling £22,000 (2013 - £13,200) and recharged expenses totalling £Nil (2013 - £60,330) to the company. There is no liability owed to Octopus Investments Limited at the year end (2013 - £273).
