

The Company entered Liquidation on 7 November 2013 and I was appointed Liquidator on the same date. I am now in a position to issue my final report

I shall now summarise the conduct of the liquidation

#### **Assets**

The director's Declaration of Solvency dated 7 November 2013 detailed the following assets capable of realisation

1) Balance at bank

£599,123 00

2) Book Debts

£12.012 00

A sum of £570,945 49 was received as cash at bank in this respect. The difference between the amount received and the total on the Declaration of Solvency relates to a corporation tax liability that was paid in full prior to me taking possession of the Company's funds.

A sum of £12,012 00 was detailed as book debts on the Declaration of Solvency, this figure was determined from the last set of accounts for the year ended 30 June 2013. However, I have received confirmation from the Company's director that the outstanding book debts amounted to US\$4,218 40. The book debt was paid in US\$1,000 00 monthly instalments prior to me taking possession of the Company's funds.

There were no further realisations save for £149 96 in bank interest and a VAT refund totalling £41 80

#### <u>Distributions</u>

The attached Receipts and Payments account details an interim distribution of £520,000 00 made to the shareholders. The remaining sum of £46,905 97 is to be distributed prior to the final meeting.

A further £69 05 has been received in respect of a corporation tax refund since the issuing of my draft report to members. This will be distributed to the members.

#### Remuneration

The time costs incurred by my staff and I in the conduct of the liquidation up to 4 April 2014 are £9,450 60 representing 65 30 hours at an average hourly rate of £144 73 I have attached a breakdown of these costs. Oury Clark staff charge their time in 6 minutes units and time is charged by both professional and secretarial staff.

The Liquidator's fee was agreed by the members to be capped at the sum of £3,500 exclusive of VAT and disbursements. This has since been drawn from the estate
